CALL TO ORDER

The meeting was called to order at 8:05 a.m. by President Peek

DECLARATION OF CONFLICT OF INTEREST

No conflicts of interest were declared.

OPPORTUNITY FOR CITIZENS TO EXPRESS ITEMS OF CONCERN

Mr. Gary Penn, of Charlya Drive, spoke regarding the proposed boathouse lighting regulation changes. He is opposed because of bugs/spiders.

Mr. Mark Carroll, of Bayshore Drive, wished everyone a Merry Christmas. Mr. Carroll wishes that the Board would seek to understand that the Lake residents have different needs than those in town.

Mrs. Jane Nettune, of Impala South, spoke regarding the proposed boathouse lighting regulation change, on behalf of the Lake Athens Property Owners Association. LAPOA is opposed to any boathouse under 60' in length being required to have dusk to dawn lighting. It would be acceptable to LAPOA for boathouse greater than 60' in length to have lighting.

Mr. Joe McKinney, of Rose Pointe, is also opposed to any boathouse lighting regulations. As a licensed electrician he is worried that some property owners may attempt to perform the electrical work themselves.

Mrs. Rita Garrett, of Oakwood subdivision, also spoke in opposition of any boathouse lighting. She stated that she hope that the Authority will allow the Lake residents to enjoy the freedoms they already have, instead of big government taking those freedoms away.

Mr. Tom Potthoff, of Zueler Hawley, also expressed his opposition to boathouse lighting regulations. For seven years, there was no electricity at his boathouse, due to distance and high cost.

Mr. Charlie Young, of Driftwood Shores, also expressed his opposition to boathouse lighting regulations. He is concerned that bright lights on boathouses may close boaters' irises and they not be able to see other hazards at night.

Ms. Ellen Key, of Impala Point Drive, also expressed her opposition to boathouse lighting regulations. She is concerned that the Authority is proposing a solution looking for a problem. She is also concerned about bugs/spiders.

A motion was made by Director Chaney, seconded by Director Gatlin, to table the rule changes until the full board can be in attendance. This motion carried unanimously.

DISCUSS AND CONSIDER AN AGREEMENT FOR ENIGNEERING SERVICES FROM KALLMAN, L.P.

Executive Director Casey explained that this agreement was to move forward with items that Mike Thornhill recommended as part of his hydrogeology report in November.

A motion was made by Director Gatlin, seconded by Director Chaney to accept this agreement for engineering services. This motion carried unanimously.

EXECUTIVE DIRECTOR REPORT

Executive Director Casey gave his report as Executive Director.
