In consideration of the payment in advance of a non-refundable permit application fee, in the amount of \$43.00, and the representations set forth in this application, the provisions of which are made a part hereof, an extension of the below installation permit is hereby requested by Permittee as follows:

This permit must be submitted and approved by the Athens Municipal Water Authority prior to installation of any structure or habitat in the waters of Lake Athens. During submission, the Lake Inspector must inspect the proposed structures to be installed, to make sure they are free from debris and pollutants. After installation, please call the Lake Inspector so that they may ensure that the structure has been installed as permitted.

The Permittee shall indemnify and hold harmless the Authority for any damages, costs, and charges to which Permittee or Authority may be subject or which Permittee or Authority may have to pay by any reason whatsoever, including but not limited to any injury to any person or property, or loss of life or property suffered or sustained by any person whatsoever arising out of the activities here permittee; Permittee shall, at his sole expense, assume the defense of any and all claims and actions for damages arising out of any and all injuries which may be brought against the Authority by third persons, and shall pay any and all judgments that may be rendered on such actions.

It is agreed that the Authority does not take any responsibility for protecting the Permittee's property nor guarantee that said property will not be used by others persons in the absence of Permittee. It being expressly intended that the Authority assumes absolutely no responsibility for the conduct of the activities herein permitted which shall be at the sole risk of the Permittee.

This Permit is granted upon the express condition and understanding that the Permittee shall conduct the permitted activities in the manner and in accordance with the mandate set forth in the rules and regulations of Athens Municipal Water Authority, and State and federal laws, pertaining to such activities as well as all rules and regulations pertaining to Lake Athens and that any breach of any rules and regulations shall automatically void this permit and any further activities by Permittee shall be deemed in violation of the penal resolutions providing a penalty for the failure to obtain a permit for the activities hereby permitted. Permittee agrees to observe and abide by all applicable Federal, State and Local laws, ordinances and regulations pertaining to the activities herein permitted and nothing contained herein shall be construed as alleviating the Permittee of any responsibility to obtain any permit, license or other approval required in connection with the activities herein permitted.

Applications for installation permits will not be considered if submitted incorrectly or are incomplete.
