DISCUSS/CONSIDER APPROVING PLANS AND AUTHORIZING STAFF TO ADVERTISE FOR BIDS FOR PLANT WELL TRANSMISSION LINE AND CONTROLS

A motion was made by Director Whatley, seconded by Director Gatlin to approve plans and authorize staff to advertise for bids for Plant Well Transmission Line and Controls. The motion carried unanimously.

EXECUTIVE DIRECTOR'S REPORT

Wylie Pirkle, Executive Director updated on the following:

- 1) Stage 1 (Voluntary) of Drought Contingency Plan has been activated.
- 2) Working on Diversion Permit for Texas Freshwater Fisheries Center, met with Texas Parks & Wildlife regarding options, and they are most interested in funding the well at the Marina.
- 3) Working on a Scope of Work for Water Well Consultant prior to having interviews.

Director Elliott questioned how long it will take to get some of the future wells operational, expressing his concerns for taxpayers having the Drought Contingency Plan implemented upon them when water is available.

Mr. Pirkle explained that A.M.W.A. must go through the process with a Consultant to develop a plan, as there are a lot of issues to be considered.

After a lengthy discussion, Mr. Pirkle stated that A.M.W.A. has a plan in place to supply water that will provide a 100 year plan for the City of Athens. However, he stated that it will be 2-5 years before there are no more water restrictions.

CONSIDER PAYMENT OF STATEMENTS

A motion was made by Director Gatlin, seconded by Director Whatley to approve the payment of statements, as presented. The motion carried unanimously.
