DISCUSS/CONSIDER APPOINTMENT TO A.M.W.A. BOARD OF DIRECTORS

Executive Director Wylie Pirkle formally presented Charles Elliott for appointment to the A.M.W.A. Board of Directors to fill the vacancy created by the resignation of W.C. "Chip" Perryman, III.

A motion was made by Director Gatlin, seconded by Director Sparkman to appoint Charles Elliott to serve as A.M.W.A. Director. The motion carried unanimously.

OATH OF OFFICE

City Secretary Pam Watson administered the Oath of Office to newly appointed Board of Director Charles Elliott.

ELECTION OF OFFICERS

A motion was made by Director Gatlin, seconded by Director Whatley to elect Mike Stover as President. The motion carried unanimously.

DISCUSS/CONSIDER RESOLUTION AMENDING RULES AND REGULATIONS CONCERNING QUALITY OF WATER AND USE AND ENJOYMENT OF LAKE ATHENS, ARTICLE 25. FEE STRUCTURE

Mr. Pirkle explained that this Resolution will enforce the Drought Contingency Plan upon Lake Athens property owners. A motion was made by Director Gatlin, seconded by Director Sparkman to approve A RESOLUTION AMENDING RULES AND REGULATIONS CONCERNING QUALITY OF WATER AND USE AND ENJOYMENT OF LAKE ATHENS, ARTICLE 25. FEE STRUCTURE. The motion carried unanimously.

DISCUSS/CONSIDER AWARDDING BIDS FOR CONSTRUCTION OF POWDER RIVER TRACT FENCING

Tyler Hendrickson, Velvin & Weeks Consulting Engineers informed the Board that three (3) bids were received for the construction of Powder River Tract fencing, recommending that the bid be awarded to low bidder, Atlas Excavation, at a total cost of \$36,700. After discussion, a motion was made by Director Whatley, seconded by Director Sparkman to award the bid for construction of Powder River Tract fencing to Atlas Excavation at a total cost of \$36,700. The motion carried unanimously.

DISCUSS/CONSIDER AUTHORIZING STAFF TO ADVERTISE FOR BIDS FOR PRODUCTION WELLS AT WATER TREATMENT PLANT, POWDER RIVER RANCH TRACT AND FRANKS TRACT

Mr. Pirkle reviewed the plans which will include wells at the Water Treatment Plant, Powder River Ranch Tract and Franks Tract. After discussion, a motion was made by Director Gatlin, seconded by Director Whatley to authorize staff to advertise for bids for production wells at Water Treatment Plant, Powder River Ranch Tract and Franks Tract. The motion carried unanimously.

- 3) Explained that vegetation control is currently budgeted, however, he recommended that no action be taken this year due to the drought and low Lake levels.
- 4) Discussed concerns with Texas Freshwater Fisheries Center and water that is being returned to Lake Athens, explaining that A.M.W.A. has to determine how to get credits back.
