# **EXECUTIVE DIRECTOR'S REPORT**

Executive Director Gatlin gave his monthly operations report.

A motion was made by Director Foster, seconded by Director Lindsey, to approve a quote from Harris Custom Boat Cradles, in the amount of \$13,000 to continue the retaining wall at Authority Headquarters. This motion carried unanimously.

Executive Director Gatlin gave the Police and Inspection Departments' reports, In Chief Dugan's absence.

A motion was made by Director Lindsey, seconded by Director Grant, to approve a variance to the Rules & Regulations Governing Authority Property & Permit Holders of Authority Property, Article 2,

Section 1, Area of a Pier or Boathouse, for 236 square feet (total boathouse square footage 1886) for Oakwood Lots 75 & 76. This motion carried unanimously.

A motion was made by Director Foster, seconded by Director Grant, to find the pier at Zueler Hawley Lots 2-3 (Wilmeth), in violation of *Rules & Regulations Governing Authority Property & Permit Holders of Authority Property*, Article 2, Section 9, Maintenance of a Pier or Boathouse. Staff is instructed to send notice that the permit holder has thirty days to remove the offending boathouse. This motion carried unanimously.

A motion was made by Director Foster, seconded by Director Lindsey, to find the pier P A Taylor Lots 64-65 (Wilkins), in violation of Rules & Regulations Governing Authority Property & Permit Holders of Authority Property, Article 2, Section 9, Maintenance of a Pier or Boathouse. Staff is instructed to send notice that the permit holder has thirty days to remove the offending boathouse. This motion carried unanimously.

A motion was made by Director Grant, seconded by Director Lindsey, to revise the Rules & Regulations Governing Authority Property & Permit Holders of Authority Property, as presented. This motion carried unanimously.

A motion was made by Director Foster, seconded by Director Lindsey, to revise the Lake Athens permit fee structure, by the CPI-U increase percentage, but on for permit, inspection and variance fees. This motion caried unanimously.
