CALL TO ORDER

The meeting was called to order at 8:00 a.m. by President Lunceford

DECLARATION OF CONFLICT OF INTEREST

No conflicts of interest were declared.

OPPORTUNITY FOR CITIZENS TO EXPRESS ITEMS OF CONCERN

Citizens below chose to speak during the agenda item, "Discuss and consider a variance request to the Rules & Regulations Governing Authority Property & Permit Holders of Authority Property, Article 2, Section 2, Length of a Pier or Boathouse, for Bear Creek Estates Lots 16 & 17":

Chief Dugan gave the police and inspection department reports.

DISCUSS AND CONSIDER A VARIANCE REQUEST TO THE RULES & REGULATIONS GOVERNING AUTHORITY PROPERTY & PERMIT HOLDERS OF AUTHORITY PROPERTY, ARTICLE 2, LENGTH OF A PIER OR BOATHOUSE

Staff explained that the variance request from Bear Creek Estates Lots 16 & 17, was largely due to the main power line that bisects the property. Current power regulations dictate a 50' easement on both sides of the line. The property owner needs to be able to extend the boathouse in order for one boat to fit under roof. Oncor granted a 5' variance to the easement. An additional 10' of boathouse length will enable to the homeowner to construct a boathouse while still having one boat under cover.

Office Manager McConnell stated that both neighbors returned their notification cards, with neither expressing opposition to the variance.

A motion was made by Director Grymonprez, seconded by Director Foster, to grant a 10' length variance for Bear Creek Estates, Lots 16 & 17. This motion carried unanimously.
