#### CONTRACT AND AGREEMENT FOR FIRE PROTECTION

THE STATE OF TEXAS COUNTY OF HENDERSON

§ § KNOW ALL MEN BY THESE PRESENTS

THIS AGREEMENT, entered into this day by and between the County of Henderson, a political subdivision of the State of Texas, hereinafter referred to as COUNTY, and the **Athens Fire Department**, Henderson County, Texas, hereinafter referred to as DEPARTMENT.

TERM OF CONTRACT AGREEMENT shall be for one year beginning January 1<sup>st</sup>, 2020 and ending December 31, 2020.

#### WITNESSETH:

WHEREAS, COUNTY desires to provide rural fire protection for the citizens of Henderson County that are not protected within a municipality.

WHEREAS, DEPARTMENT will maintain operational firefighting apparatus and equipment to meet the needs of incidents to which they respond. I.e.; brush truck for response to grass/wild-land fires; pumper, tender/tanker, engine for response to structural fires; etc.

WHEREAS, DEPARTMENT is a duly incorporated fire department and duly certified and recognized by the State of Texas as a fire department and in good standing with the State of Texas and the United States of America.

**WHEREAS**, the parties hereto desire that an agreement be made to provide payment for rural fire protection in the County of Henderson, State of Texas;

**NOW THEREFORE**, it is UNDERSTOOD and AGREED by and between the parties as follows:

This Contract and Agreement (hereinafter referred to as the Agreement) is made under authority of and subject to the provisions of Texas Government Code 791 and Texas Local Government Code Chapter 352.

COUNTY shall pay DEPARTMENT \$11,068.00 for the year 2020 in consideration for the Department's agreement and commitment to provide rural fire protection, rescue and other emergency response in the said DEPARTMENT'S response area and maintain active membership by attendance at the Henderson County Fire Chiefs' Association meetings.

DEPARTMENT shall maintain a training program in good standing with either of the state fire agencies; State Firemen's and Fire Marshals Association or Texas Commission on Fire Protection. Note: Enrollment and participation in either of the above listed training programs is not required for all DEPARTMENT personnel, only that the DEPARTMENT is in good standing with one of the above agencies.

DEPARTMENT will ensure that all members are in compliance with the President's Homeland Security Directive (HSPD) 5 by maintaining current National Incident Management System training standards.

DEPARTMENT shall purchase and keep in force at all times insurance for the minimum amounts of liability under the Texas Torts Claims Act, as the act then exists, which currently is: \$100,000 for each person up to \$300,000 per incident for bodily injury or death: and \$100,000 per each incident for property damage, and may

hereafter be amended or recodify. The DEPARTMENT shall provide proof of such insurance policy or policies to the County Fire Marshall as evidence that such insurance is in full force and effect, upon the executing this Agreement.

Furthermore, DEPARTMENT shall provide current list of all equipment and apparatus to the County Fire Marshal upon executing this Agreement.

DEPARTMENT shall maintain the ability to communicate on the Henderson County radio frequencies and communicate on the following mutual aid channels:

V-CALL-10 V-FIRE-21 V-FIRE-22 V-FIRE-23 V-FIRE-24 V-FIRE-25 V-FIRE-26 V-TAC-36

DEPARTMENT shall maintain a current record of incident responses in either the Texas Fire Incident Reporting System ("TexFIRS") or the National Fire Incident Reporting System ("NFIRS"). Department shall file all incident reports to either NFIRS or TexFIRS every month, in accordance to the rules and regulations of the respective reporting systems and all reporting must be current within 60 days.

DEPARTMENT shall reserve the right to charge a reasonable fee for the performance of emergency services, and all such fees collected shall accrue to DEPARTMENT.

It is expressly understood and agreed upon that the DEPARTMENT is an independent contractor for the purpose of this Agreement and that COUNTY is interested only in the end result, to-wit: Fire Protection, rescue, and other emergency responses for the rural residents of Henderson County, Texas. COUNTY shall not acquire any right, title or interest over any equipment owned, leased or otherwise operated by DEPARTMENT, nor shall COUNTY have any direction or control over DEPARTMENT or its personnel.

COUNTY reserves the right to evaluate compliance with the provisions of this Agreement by reviewing any incident reporting documentation to TexFIRS or NFIRS; and the right to access and audit the financial records and books of DEPARTMENT at any time during the term of this contract.

Failure to comply with the provisions of this Agreement may result in the withholding of all monetary consideration to DEPARTMENT by COUNTY. In the event of any default of this Agreement, COUNTY shall notify DEPARTMENT of default with a letter, sent by certified mail to DEPARTMENT. DEPARTMENT shall have 60 days from the receipt of the certified mail, to remedy the default. In the event default is not corrected in a timely manner, DEPARTMENT shall not be eligible for any future monetary consideration from COUNTY, without first obtaining Henderson County Commissioners' Court approval.

#### **Finance Department**

### **Budget Report - 41.67% of FY 2020 Completed**

**General Fund Revenue and Expense Summary:** General Fund revenues to date total \$6,633,516.21 or 58.54% of budget. General Fund expenditures to date total \$4,362,069.30 plus encumbrances of \$386,728.54 for a total of \$4,748,797.84 or 41.45% of budget.

The City's current tax levy reports 92.53% collection of budgeted amounts. Total maintenance and operations property tax revenue to date is \$4,025,543.69. The bulk of Ad Valorem revenues are received between the months of December through February.

The City's total sales tax budget (2 cents) is estimated at a net \$4,301,250. The City has received a total of \$2,731,127.68 to date with the portion retained by the City totaling \$2,048,345.76. The Athens Economic Development Corporation receives ½ cent of collections via a transfer from the General Fund each month. The total YTD transfers to AEDC is \$682,781.92.

#### Important Expenditure Notations:

- PO Encumbrances from FY 2019 carried into FY 2020 via Budget Amendment approved December 9, 2019:
  - o 10-532-6520; \$147,256 for Carroll Street Improvements incomplete at 9/30/19
  - o 10-553-6204; \$57,297 for Portable Radios for Patrol Officers incomplete at 9/30/19
- Council approved the prepayment of the Wildland Fire Engine in the amount of \$469,188. This expenditure is classified as a prepaid and is not reflected as a General Fund expenditure, although cash was decreased to complete the purchase. FAST Grant funds will be received upon delivery of the Engine in March 2021.

<u>Airport Fund:</u> Revenues YTD total \$36,838.03 or 70.30% of budget. This sharp increase is due to the receipt of RAMP Grant reimbursement in the amount of \$12,350.22. Expenditures YTD equal \$39,436.19 or 76.06% of budget. The higher than anticipated increase in YTD budgeted expense is due to the replacement of the Airport's beacon and additional required maintenance.

### **Budget Report - 41.67% of FY 2020 Completed**

<u>Hotel/Motel Occupancy Fund:</u> Revenues YTD total \$140,082.93 or 46.46% of budget. Expenditures YTD equal \$112,059.52 plus encumbrances of \$56,996 for a total of \$169,055.52 or 55.21% of budget. Purchase Orders for Aid to Other Organizations are reflected in the encumbrance column totaling \$40,000, plus advertising encumbrances of \$11,000 and \$5,000 for Façade Improvements.

<u>Capital Projects Fund:</u> Interest earned YTD is \$26,597.40 or 21.28% of budgeted revenues. Expenditures YTD are \$171,514.30 plus encumbrances of \$53,750 for a total of \$225,264.30 or 6.07% of budgeted amounts. Expenditures this period include \$132,983.62 for the Cain Center Project to PGAL and \$1,293.10 for improvements at Central Fire Station.

<u>Water and Sewer Fund:</u> The City's Utility revenue YTD is \$2,367,537.19 or 39.88% of budgeted revenues. Water related income totals \$1,183,750.45, sewer related income totals \$1,098,173.88 and other revenues total \$85,612.86. Expenditures YTD are \$1,758,905.01 plus encumbrances of \$565,823.44 for a total of \$2,324,728.45 or 38.30% of budgeted expenditures.



We are in the middle of a public health crisis that is rapidly changing. Through this crisis, our primary concern is the health and safety of voters, election workers, and our local election officials. ### ELECTION ADVISORY No. 2020-12

TO: Election Officials

FROM: Keith Ingram, Director of Elections

DATE: March 18, 2020

RE: Actions for May 2, 2020 Uniform Election Date

The purpose of this advisory is to provide guidance to local political subdivisions regarding their options for any general or special elections that have been ordered for the May 2, 2020 uniform election date. Pursuant to Section 418.016 of the Texas Government Code, the Governor has issued a proclamation suspending certain provisions of the Texas Election Code and the Texas Water Code to allow all local political subdivisions that are utilizing the May 2, 2020 uniform election date to postpone their election to the November 3, 2020 uniform election date. Pursuant to Texas Election Code 31.003 and 31.004, our office has issued the following guidelines for entities that choose to exercise this authority and postpone their election to the November uniform election date.

#### **Effect of Postponement of Election**

- Candidate Filings: By postponing their election date, the political subdivision is preserving all candidate filings and ballot order actions that have already been taken. The postponement does not have the effect of reopening candidate filings.
  - o **Deadlines related to Candidate Filings, Declarations of Ineligibility, Withdrawals or Death:** The deadlines that apply to the November 3, 2020 election would apply to all candidates who are currently on the ballot for the May 2, 2020 election.
- Ballot By Mail Requests: All applications for a ballot by mail (ABBMs) that were filed for the May 2, 2020 election that are marked annual would apply for the November 3, 2020 election. All single use ABBMs that were submitted for reasons of age or disability would still be valid for the November 3, 2020 election. If a single use ABBM was submitted and indicated the reason for voting by mail was due to absence from the county, this ABBM would not be valid as the applicable election date has changed. However, we would recommend that the political subdivision send a letter to these voters along with a new ABBM in case the circumstances

surrounding their absence from the county are still valid or the voter is otherwise eligible to vote by mail.

- **Ballots by Mail:** If a political subdivision has already sent out mail ballots, those mail ballots that are returned would still be valid for the November 3, 2020 postponed election date.
- **Election Records:** All records, including candidate filings, applications to vote by mail, ballot proofs, and printed ballots shall be retained and preserved.
  - Printed Ballots: If your ballots have already been printed up, you may be able to reuse them for November. However, if you must change your ballot to reflect any corrections or changes that occur between now and November, you would treat the original ballots as you would in a traditional ballot correction and those ballots should be destroyed in accordance with Section 52.0064 of the Texas Election Code.
- Requirement to use County Election Precincts in November 2020: Per Section 42.002 of the Texas Election Code, county election precincts are required for all elections occurring in November 2020. You will need to work with your county election officer to determine whether you need to make any modifications to your ballot in light of this requirement.
- Requirement for County Election Officer to contract with Local Political Subdivisions: All county election officers are required to contract with local political subdivisions that postponed their May 2, 2020 election and that request a contract for election services or a joint election agreement with their county election officer pursuant to the Governor's suspension of certain Texas Election Code provisions.
- Office Hours: The relevant dates for maintaining office hours for election purposes will be based on the November uniform election date rather than the May election date. Under Section 31.122 of the Texas Election Code, those office hours will need to be maintained for at least three hours each day, during regular office hours, on regular business days between September 14, 2020 and December 13, 2020. However, these entities should post contact information for individuals to contact their office about election-related issues during the timeframe that those offices may be closed over the coming months.
- **Holdovers in Public Office:** Under Art. XVI, Sec. 17 of the Texas Constitution, the individuals who currently hold public offices that are scheduled to be on the ballot on the May uniform election date will continue to exercise the duties of those offices until the new officers take their oaths of office, following the November uniform election date.
- Campaign Finance Filings: Please contact the Texas Ethics Commission for further guidance on how these modified timelines will affect any campaign finance reporting requirements. Their office can be reached at (512) 463-5800.
- Candidates on the ballot in both May and November: For candidates that may be running for two offices (one normally occurring in May and one normally occurring in November), these candidates will not be removed from the ballot as they are separate elections that are normally not occurring on the same date.

#### Required Action by Governing Body to Move Election Date

In order to utilize this move, the governing body of the political subdivisions holding the elections must **order** the postponement of their election to the November 3, 2020 uniform election date. The order for this official action should contain the following items:

- 1. A reference to the proclamation that authorizes the entity to postpone their election date, and the fact that the political subdivision is exercising this authority.
- 2. Confirmation that the candidate filings for the election will remain valid for the election held on the November date and that the filing period will not be re-opened for the November election date.
- 3. Confirmation that all ABBMs for voters that are voting by mail due to being over the age of 65 or due to disability will still be valid for the postponed election, and that ABBMs for voters who submitted ABBMs based on expected absence from the county would not be valid for the postponed election.
- 4. The major relevant dates for the November election, including the voter registration deadline (October 5, 2020), the deadline to submit an ABBM (October 23, 2020), and the dates for early voting (October 19, 2020 October 30, 2020).

#### **Necessary Revisions to Order of Election**

In addition, the entity will need to meet by August 17, 2020 to make any necessary revisions to the entity's original order of election. Those revisions may include:

- 1. The change to the date of the election;
- 2. Any change in location of the main early voting location;
- 3. Any changes to early voting dates and hours, including weekend early voting;
- 4. Any changes to the identity of the early voting clerk and their contact information; or
- 5. Any changes to branch early voting locations.

If you are holding a bond election, you may need to make additional revisions to your order of election for that bond election. If this is the case, we recommend reaching out to your bond counsel for additional guidance.

#### **Securing Election Records**

All election records should be stored and secured during the postponement period. This may require your entity to use preservation methods that are similar to the methods you would use during the preservation period after the election has occurred. This includes:

- Storing returned ballots by mail in locked, sealed ballot boxes.
- Securely storing any unused ballots.
- Securely retaining any relevant election records, including candidate applications and ABBMs.

#### **Voting System Equipment**

If you are leasing voting system equipment from the county or directly from the vendor, then you may need to contact your vendor or your county regarding any necessary modifications to those lease agreements or to modify your procedures and timelines for receiving that equipment.

#### **Open Meeting Requirements**

ADV 2020-12 Page 4

The Governor has suspended and modified certain open meeting requirements pursuant to his disaster declaration. These changes include allowing the entity to establish procedures for telephonic or videoconferenced meetings of governmental bodies that are accessible to the public.

These procedures must include a process for members of the public to participate and address the governmental body in those meetings, notice to the public on the means of participating remotely, and access to the public for recordings of those meetings.

For more information, please review the applicable <u>documentation</u> from the Governor's Office or contact the Office of the Attorney General.

#### Update Official Websites and Notify Media

Any entities that are exercising this authority to postpone their election date must post notice on the entity's website and should alert any local media organizations regarding this change to their election date.

The entity must also provide notice to their county election officer regarding this change, as the county is required to post the entity's notice of election on the county's website no later than the 60th day before the date of the election under Election Code 4.008. If that election date will be changing due to the entity's decision to postpone the election then the entity must provide a revised notice to the county for posting on the county's website.

**SECTION 3:** Should any section, subsection, sentence, clause or phrase of this Resolution be declared unconstitutional or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Resolution shall remain in full force and effect. The City Council hereby declares that it would have passed this Resolution, and each section, subsection, sentence, clause, or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared unconstitutional or invalid.

**SECTION 4:** This Resolution shall become effective immediately upon its passage.

#### DECLARATION OF LOCAL DISASTER DUE TO PUBLIC HEALTH EMERGENCY

WHEREAS the World Health Organization has declared the coronavirus, now designated COVID-19, as a global pandemic on March 11, 2020; and

WHEREAS, COVID-19 was first detected in Wuhan, China in December 2019; and

**WHEREAS**, symptoms of COVID-19 can range from mild to severe illness and cause further complications including death; and

WHEREAS, the COVID-19 virus mainly spreads between people who are in close contact with one another through respiratory droplets produced when an infected person coughs or sneezes; and

**WHEREAS**, the continued worldwide spread of COVID-19 presents an imminent threat of widespread illness, which requires emergency action for the protection of the people of Athens, Texas; and

WHEREAS, the implementation of mitigation strategies can slow the transmission of the disease; and

WHEREAS, the Small Business Association (SBA) has designated COVID-19 as a qualifying event for the provision of Economic Injury Disaster Loans for businesses and private non-profits in affected communities.

WHEREAS, this Declaration activates the City's Emergency Management plan; and

The original site plan was approved in October of 2017. A site plan amendment was approved in September of 2018. A site plan amendment concerning the sign package for Lot 1 (Panda Express) was approved last month.

The current proposal shows the following changes:

- o Updated drive approach locations as approved by TXDOT
- o Increase screening wall height to 10' (which is roughly 8' above the adjacent grade on the Triton side of the wall)
  - Proposing the installation of a temporary fence during construction. The previous site plan required the permanent wall to be installed prior to any vertical construction on the site.
- o Proposing wall signs on 3 facades (north, east and west) with following restrictions
  - Street facing sign allowable square footage maintained under current city sign ordinance
  - East and west facing wall signs shall be no more than 50% of the allowable square footage of the street facing sign
  - East and west facing wall signs shall pertain to freestanding buildings, not tenants meaning the additional sign on multitenant retail buildings will be at the developer's discretion which tenant is allowed to utilize that additional sign area.
  - No "rear" facing signs are allowed
- Monument sign requirement is unchanged

The Future Land Use Plan designates this area as Low Density Residential.

**WHEREAS**, on the 9<sup>th</sup> day of March 2020, the City Council of the City of Athens, Texas after due notice as required by law, held a public hearing for said site plan and heard from those opposed to said modification and those in favor of same. After the close of the public hearing, the ordinance amendment was read aloud for the first time as required by Article III, Section 3.11 of the City of Athens Charter.

## NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS

Section 1. The Zoning Map described in Chapter I, Section 3 of the City of Athens Zoning Ordinance is hereby amended to grant the site plan approval for Triton Athens I, LLC as presented, with the added stipulations that wall signs shall not be allowed on the east and west building facades, the screening wall shall tie into the screening wall on the neighboring property (Burger King) and the top of the entire wall shall be at the minimum elevation of 516 feet, and temporary fencing shall be allowed during construction, but the permanent wall shall be completed prior to the issuance of any certificate of occupancy for the property.

Section 2. Should any clause, phrase, sentence section of this Ordinance be deemed invalid or unconstitutional by a court of competent jurisdiction, said finding shall not affect the remaining clauses, phrases, sentences or sections of this Ordinance.


Section 3. Any ordinance, resolution or order previously passed and/or adopted by the City Council, or any part thereof, if found to be in conflict with the provisions of this Ordinance, shall

be resolved in favor of the terms and conditions of this Ordinance, and any prior conflicting ordinance, resolution or order or any part thereof, is hereby repealed to the extent of said conflict.

Section 4. This ordinance shall be and become effective from and after its adoption and publication in accordance with the provisions of the Charter of the City of Athens, Texas.



Hi Audrey,

I've had a chance to review the plan and I have some questions.

Due to the change in elevation of the development, I'm concerned about the construction of the retention basin behind my property. Can I get information about how that will be constructed so as not to overflow or otherwise create run off onto my property?

With respect to the actual wall facing my property, I have the following comments:

- The perimeter wall at my property line is called out as 18 foot high on the drawing, but 10 foot under "Screening" in the notes box to the right. Please confirm the intention is to construct an 18 foot tall wall?
- The notes indicate a screen wall to be placed during construction instead of building the wall prior to construction as called out in the Ordinance. Is this correct?
- If so, will the 18' wall be built in the same location as the existing wall? If so, what modifications will be necessary to support this size structure?
- I believe that the developer's failure to match the existing wall finish that faces my property
  makes an unsightly finished product. More than doubling the height as well as an abrupt
  transition to the plain block will have a very negative effect on my property. Additionally, the
  existing wall that extends approximately 25 foot parallel to my property line remains 8 foot tall,
  and will not prevent light and noise impacts to my property from Panda Express.
- With regard to the signage mentioned at the east and west sides of the building, I would note
  that the building elevations noted in the previous request for signage were 23' above the new
  grade. I assume the 18' wall is measured from the original grade at the current footing
  location. If this is the case, the proposed signage will still likely be visible from my property
  and certainly from my neighbor to the west's property. I object to any additional signage on the
  east or west sides of the buildings.

I respectfully request the Commission not approve this plan as submitted, since it will not completely rectify the repercussions to the adjacent properties from the elevation change and creates an unsightly barrier between the longstanding existing neighborhood and the commercial property.

As I am out of town on business, I am not available to attend the Zoning Commission meeting in person on Monday, If the City has a way for me to call in to be able to hear the meeting, I would be very grateful to participate that way. Please let me know if there is a number I can call in, or if Skype or another method of participating remotely is available.
