

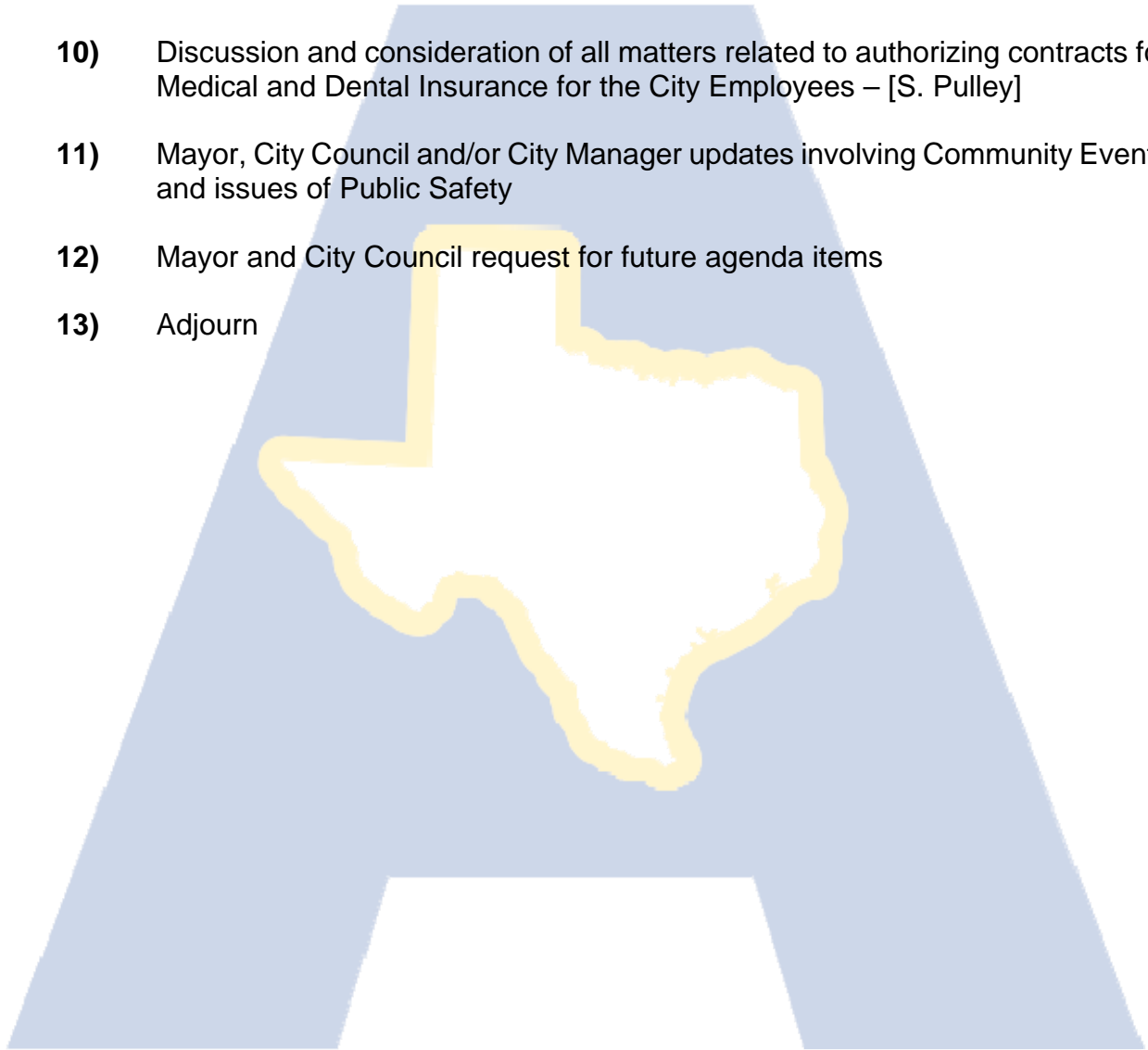


NOTICE TO PUBLIC

Notice is hereby given that the City Council of the City of Athens, Texas will meet in Regular Session on Monday, November 28, 2016, 5:30 p.m. in the Derek D. Daniels Conference Room of the Athens Partnership Center, 201 W. Corsicana St., Athens, Texas to consider the following:

- 1) Invocation
- 2) Declaration of Conflict of Interest
- 3) Enter into Joint Work Session with Members of the Athens Municipal Water Authority
 - a) To open a dialogue and discuss matters pertaining to the agreement between Athens Municipal Water Authority and the City of Athens, including: facilities, operations, and management of all water related issues
 - b) Discuss the working relationship between Athens Municipal Water Authority and the City of Athens
- 4) Consent Agenda:
(All matters listed are considered to be routine by the City Council and will be enacted by one motion. There will be no separate discussion of these items unless requested by a member of the City Council. The item may subsequently be removed from the Consent Agenda to be considered separately.)

Members of the City Council are prohibited from entering into deliberation.)

- 9) Discussion and consideration of all matters related to authorizing the purchase of six (6) vehicles for the police department from Sam Pack's Five Star Ford, through the State of Texas purchasing contract, in the amount of \$149,744.00 – [B. Hill]
- 10) Discussion and consideration of all matters related to authorizing contracts for Medical and Dental Insurance for the City Employees – [S. Pulley]
- 11) Mayor, City Council and/or City Manager updates involving Community Events and issues of Public Safety

If during the course of the meeting covered by this notice, the City Council should determine that a closed or executive meeting or session of the City Council or a consultation with the attorney for the City should be held or is required, then such closed or executive meeting or session or consultation with attorney as authorized by the Texas Open Meetings Act, Texas Government Code § 551.001 et. seq., will be held by the City Council at the date, hour and place given in this notice as the City Council may conveniently meet in such closed or executive meeting or session or consult with the attorney for the City concerning any and all subjects and for any and all purposes permitted by the Act, including, but not limited to, the following sanctions and purposes:

Texas Government Code Section:

§ 551.071 - Private consultation with the attorney for the City.

§ 551.072 - Discussing purchase, exchange, lease or value of real property.

§ 551.074 - Discussing personnel or to hear complaints or charges against personnel or officials.
