Notice is hereby given that the City Council of the City of Athens, Texas will meet in Regular Session on Tuesday, May 29, 2018, 5:30 p.m. in the Derek D. Daniels Conference Room of the Athens Partnership Center, 201 W. Corsicana St., Athens, Texas to consider the following:
