Comments on such non-agenda items shall be limited to three minutes. The Substandard Building Commission will not comment on items not on the agenda; however, the Substandard Building Commission may refer the item to city staff for research, resolution or referral of the matter to the Substandard Building Commission as a future agenda item.
