CONSIDER APPROVING MINUTES FROM THE APRIL 3, 2014
REGULAR SESSION

A motion was made by Member Robson, seconded by Member Grant to approve the minutes of the April 3, 2014 Regular Session, as written. The motion carried unanimously.

DISCUSS/CONSIDER AUTHORIZING RENEWAL OF LEASE
AGREEMENT WITH CARROLL DYSON (DYSON AVIATION
COMPANY) FOR CITY OWNED LAND AND IMPROVEMENTS
(HANGAR LH#1) AT ATHENS MUNICIPAL AIRPORT

A motion was made by Member Grant, seconded by Member Robson to recommend that Council approve the renewal of Lease Agreement with Carroll Dyson (Dyson Aviation Company) for City owned land and improvements (Hangar LH#1) at Athens Municipal Airport at a rate of \$700.00 per month for a 2-year term. The motion carried unanimously.

DISCUSS/CONSIDER AUTHORIZING RENEWAL OF LEASE
AGREEMENT WITH ATHENS JET CENTER FOR CITY OWNED LAND
AND IMPROVEMENTS (HANGAR LH#2) AT ATHENS MUNICIPAL
AIRPORT

A motion was made by Member Grant, seconded by Member Robson to recommend that Council approve the renewal of Lease Agreement with Athens Jet Center for City owned land and improvements (Hangar LH#2) at Athens Municipal Airport at a rate of \$500.00 per month for a 3-year term. The motion carried unanimously.

Member Grant presented the Board with the Airport Liaison Scope of Work, Review Process and Reimbursement, as provided by Phil Becker. Member Grant reviewed Mr. Becker's qualifications for Airport Liaison which included decades of aviation consultancy experience. Member Grant also stated that Mr. Becker would be a benefit for Airport planning and for the future of the Athens Municipal Airport. After discussion, Member Grant made a motion, seconded by Member Robson to recommend the Council appoint Mr. Phil Becker as the Consultant/Liaison to Texas Department of Transportation Aviation Division and Federal Aviation Administration for Athens Municipal Airport. The motion carried unanimously.

UPDATE FROM PHIL BECKER, CONSULTANT/LIAISON TO TEXAS
DEPARTMENT OF TRANSPORTATION AVIATION DIVISION AND
FEDERAL AVIATION ADMINISTRATION

Mr. Becker stated that he was anticipating meeting with Texas Department of Transportation Aviation representative Dave Fulton in Austin the following week. He stated that the subjects to be discussed are possible re-alignment of proposed new runway, proposed length and width of new runway and the extension of present runway not being acceptable.

DISCUSS STATUS OF AIRPORT IMPROVEMENTS SURVEYS

Mr. Becker stated that he will get clarification as to why all operations reported on returned surveys are not being allowed to be counted toward the five hundred (500) total operations needed for airport expansion.

SUPPLEMENTAL AGENDA:
DISCUSS/CONSIDER POSSIBLE ACTION REGARDING MITIGATION
OF VERTICAL PENETRATION OFF OF RUNWAY 35 AT ATHENS
MUNICIPAL AIRPORT

Gary Crecelius, Director of Planning & Development, informed the Board that the City had received notification from the Federal Aviation Administration (FAA) indicating that there were possibly fourteen (14) groups of trees that penetrate the IAP Visual 20:1 visual surface for Runway 35. Mr. Crecelius stated that the penetration had to be mitigated by either lighting the trees, topping the trees or removing the trees. He further stated that failure to mitigate the penetration would result in night restrictions being placed on Runway 35. Mr. Becker recommended that the services of an arborist be utilized to determine which trees should be removed or topped.

After discussion, a motion was made by Member Cain, seconded by Member Robson to recommend to Council that the services of a licensed professional surveyor be secured for the purpose of locating, identifying, marking and determining the height of the trees reported to be penetrating the IAP Visual 20:1 visual surface for Runway 35 and then take the appropriate measure regarding mitigation of vertical penetration off of Runway 35. The motion carried unanimously.

DISCUSS/CONSIDER APPROVING HANGAR CONSTRUCTION
APPLICATION FOR AREA 1, LOT 5 AT ATHENS MUNICIPAL AIRPORT, AS

Gary Crecelius, Director of Planning and Development, stated that Wayne Addkison was requesting a land lease for 3900 sq. ft. (60 x 65) in Area 1 of the Athens Municipal Airport. He explained that Mr. Addkison would like to build a 3,000 sq. ft. (50 x 60) hangar that would be located north of their existing 100 x 100 sq. ft. hangar. A motion was made by Member Tidmore, seconded by Member Grant to recommend approving hangar construction application for Area 1, Lot 5 at Athens Municipal Airport, as requested by Wayne Addkison. The motion carried unanimously.

UPDATE FROM PHIL BECKER, CONSULTANT/LIAISON TO TEXAS
DEPARTMENT OF TRANSPORTATION AVIATION DIVISION AND FEDERAL
AVIATION ADMINISTRATION

Phil Becker stated that he met with Texas Department of Transportation Aviation Representatives Dave Fulton, Greg Miller and Chris Munroe in Austin on July 22, 2014. He stated that some of the items that were discussed included: 1) clarity of meaning of penalized operations; 2) length of balanced runway length for safe operations; 3) options for realignment of runway; 4) City's desire for a runway 100 ft. x 6500 ft.; 5) economic development to City with runway extension; and 6) incremental cost of runway extension/expansion project.
