PUBLIC HEARING ON THE PROPOSED FISCAL YEAR 2018 BUDGET

Mayor Montgomery opened the public hearing.

Gary Whittle, Interim City Manager, presented the proposed Fiscal Year 2018 Budget for the City of Athens. Including: Proposed Tax Rate remaining at \$.0685221.

Steve Barksdale asked for a definition of the SCADA System with Ryan Adams, Managing Director of Public Services, explaining the system.

Bob Morton asked if the funding for the Cain Center Project is included in the proposed budget. Marty Coursey, Director of Finance, explained funding for the Cain Center Project is through Certificate of Obligations.

Aaron Smith asked if the debt service figures were included in the debt payment.

Lacey Lowry commended City Council and Staff on what they were doing to make Athens a better place. She asked if there was an update on the forensic audit. She also had questions about the Fire and Police proposed budget.

The public hearing was closed.

PUBLIC HEARING ON THE PROPOSED TAX RATE FOR FISCAL YEAR $2018\,$

Ms. Coursey presented the proposed Tax Rate for Fiscal Year 2018. She informed Council that there is a revenue tax increase because the effective tax rate is lower than the tax rate from last year.

Mayor Montgomery opened the public hearing.

Deborah Deas asked if the budget would be approved on August 28, 2017, with Ms. Coursey stating the final reading of the Ordinance will appear on the August 28, 2017 agenda.

Lacey Lowry thanked Mayor and Council for allowing the tax rate to remain the same.

Lisa Denton, Executive Director of Athens Economic Development Corporation (AEDC), explained the terms of Will Traxson and Cliff Barrett will expire on September 30, 2017 from the AEDC Board of Directors. She stated that both members have expressed their desire for reappointment.

A motion was made by Councilmember McCain, seconded by Councilmember Winn to approve the reappointments of Will Traxson and Cliff Barrett to the AEDC Board of Directors. The motion carried unanimously.

Ms. Denton explained that Mr. Laird and Mr. Cox have reached term limits for serving on the Board. She stated that Cliff Bomer and Randy Jones have both expressed a desire to serve on the AEDC Board.

A motion was made by Councilmember Winn, seconded by Councilwoman Clay to approve the appointment of Cliff Bomer and Randy Jones to the AEDC Board of Directors. The motion carried unanimously.

DISCUSSION OF ALL MATTERS RELATED TO A CITIZEN'S REQUEST FOR DEANNEXATION OF PROPERTY WITHIN THE CITY LIMITS – MAYOR MONTGOMERY A) F.M. TRIMBLE, A-766

Mayor Montgomery stated that the city is not in the practice of deannexing property within the city limits. The Mayor allowed Stan Taylor to speak on the behalf of James & Carolyn Ray about the desires of the Ray family wanting the Council to consider deannexation of the Ray's property due to a bad survey in 1965.
