INVOCATION

The invocation was given by Jason Smith.

DECLARATION OF CONFLICT OF INTEREST

No action was taken.

PRESENTATION OF LIFE SAVING AWARDS

Chief McQueary, presented Life Saving Awards to Sarah E. Barnes and Jonathon T. Toney for their actions on June 10, 2016 in rescuing a young male that was discovered at the bottom of the pool at the Cain Center. Chief McQueary stated, that Ms. Barnes jumped into the pool and brought the young man up. Mr. Toney helped her bring the young male out of the pool; with Ms. Barnes immediately performing life saving measures with the help of Mr. Toney.

Chief McQueary also presented a Life Saving Award to Jay Kinzer for his actions taken on April 22, 2017. Chief McQueary explained, a man was trapped on the second floor of a well involved house fire. Mr. Kinzer raised a ladder to the second floor. He climbed the ladder and saw the man. He tried to coax the man to him so he could help bring him down. Mr. Kinzer attempted several times at yelling for the man to come to him until the heat became too intense and made Mr. Kinzer retreat.

Mr. Kinzer stated he did what anyone would do. He further stated how phenomenal Chief McQueary and his department were that night. He stated his house would not be standing if it were not for the fire department.

1. Mr. Muecke expressed his concerns about the Splash pad at Kiwanis Park and the waste of water. He also stated there is no written policy for criminal trespassing in the Athens Police Department.

MANAGING DIRECTORS – REPORTS AND PROJECT UPDATES **a)** ADMINISTRATIVE SERVICES

Ryan Adams, Managing Director of Administrative Services, introduced Jennifer Robertson as the new Human Resources Director. He also acknowledged Leigh Corson in her role as Interim Human Resources Director.

Mr. Adams provided the following updates:

- 1. Full rehabilitation of the water tank project is progressing grandly; should be complete by the end of July
- 2. One (1) week remaining in the Legislator Session. He stated the City's Legislative Program Annexation and Revenue Caps were a concern, however both appear to be non-issues for the City

b) DEVELOPMENT SERVICES

Barbara Holly, Managing Director of Development Services, provided the following updates:

- 1. One hundred (100) building permits for the calendar year with eighteen (18) permits issued in the month of April 2017 for a total value of \$23,317,776 for the calendar year
- 2. Planning review and inspections occurring in house, with the exception of plumbing
- 3. One hundred -ten (110) notice of violations, one hundred- eighteen (118) inspections, eight (8) citations and seventy-seven (77) voluntary abatements issued for Code Enforcements

c) COMMUNITY SERVICES

Thanasis Kombos, Managing Director of Community Services, provided the following updates:

- 1. Street rehabilitation overlay program is progressing
- 2. Grant for O.D. Baggett Park has been received
- 3. Texan Theater Project, demolishing phase should be complete this week

Ms. Holly, explained the plat is taking two (2) lots and creating one (1) lot for the future auto part store located at E. Tyler and Dull Averiette. She stated staff recommends approval.

A motion was made Councilmember McCain, seconded by Councilmember Smith to approve a request from 3Gen Properties for an amending replat to combine two lots into one for a future ABC Auto at 600 E. Tyler Street. The motion carried unanimously.
