## INTRODUCTION OF AGENDA

Philip Rodriguez, City Manager, introduced the agenda for the Vision and Planning Session. He explained that the City had a Council Member resign. He stated per the City of Athens' Charter, the City Council must appoint someone to fill the vacancy within 30 days. There was discussion regarding the appointment to City Council. Mr. Rodriguez stated the item will appear on the next City Council Agenda.

Council Member Ed McCain entered the room.

Mr. Rodriguez thanked the City Council for attending the Vision and Planning Session. He discussed the decision making process and informed the Council, the City of Athens has a Council/Manager form of government with a separation of politics and administration. There was further discussion.

- 2. Look at areas to annex including preparing an Annexation Plan
- 3. Expansion of Services eastward
- 4. Refresh the Comprehensive Plan
- 5. Restrict livestock from residential zoning
- 6. Restrict barbed wire fencing in residentially zoned areas
- 7. Enhance Code Enforcement city-wide
- 8. Create growth strategy with tools
- 9. Investigate housing incentives for first time homebuyers
- 10. Fee structure for mitigation and administrative fees
- 11. Appraisal of City Hall and proceed with competitive sealed bid to sell excess real estate

DISCUSSION AND CONSIDERATION OF ALL MATTERS RELATED TO BARBED WIRE FENCING IN RESIDENTIAL DISTRICTS AND POSSIBLE MORATORIUM
