The meeting was called to order at 8:34 A.M. by President Will Traxson for all agenda items. A quorum was present.

Update of the following: East Texas Arboretum and Botanical Society and Henderson County Regional Fair Park Community Development Grants

Finance Director Mandie Quigg updated the Board on the East Texas Arboretum and Botanical Society and Henderson County Fair Park Community Development Grants. She stated both projects have been completed with a total fiscal impact of \$19,000 for Henderson County Fair Park and \$5,000 to the East Texas Arboretum.

Finance Director Mandie Quigg brought to the Board's attention there were two items submitted

for payment that were in question. Rental of a restroom trailer for \$5500.00 and two employees' time cards for Holiday time and bonuses totaling almost \$1200.00. She stated these items do not improve the property.

There was discussion concerning the payment of bonuses and a temporary restroom facility. A final motion was made by Cliff Bomer and seconded by Carmen Hunt to pay the amended amount of \$27,347.55. The motion passed 7-0.

Consider discussion and possible action regarding the approval of an Administrative Services Agreement between the AEDC Board and the City of Athens

There was discussion regarding the Board maintaining the control and delegating duties to the City of Athens.

Carmen Hunt made a motion that this item be tabled until Will Traxson confers with Jeff Moore and make changes. It was seconded by Cliff Bomer. The motion carried 7-0.

Consider discussion and possible action regarding options for AEDC to assist in the planning and development of a new Police Station

President Will Traxson discussed possibilities to help with funding of a new police station. There was discussion. No further action was taken.
