The meeting was called to order at 8:00 a.m. by President Lilly for all agenda items. A quorum was present.

Consider discussion and possible approval of minutes from the following AEDC Meetings:

 John Trent made a motion to approve the minutes, as presented. Cliff Barrett seconded the motion and motion carried 6-0.

Consider discussion and possible action on the following items associated with AEDC financials.

A. February 2018 finance reports

The board received an update from Lisa Denton on the revenues, expenditures and commitments of AEDC for the month of February 2018.

Cliff Barrett made a motion to approve the February financials. Carmen Hunt seconded and motion carried 6-0.

Update on Freeport Tax Exemption

Lisa Denton will be presenting at a workshop for Henderson County Commissioner's Court later today. AEDC has collected all but two of the participating companies' applications; currently four businesses have opted out. Contracts will be presented to the City and ISD on 3/26/18.

Consider Discussion and possible action on the following AEDC Grant Programs:

A. Business Assistance Grant Program

1. <u>Athens Screen Printing</u> – Applicant proposes to make façade improvements in the amount of \$22,729.25. This project qualifies for a 50% matching grant, in the amount of \$11,364.25.

Will Traxson made a motion to approve grant funding, in an amount not to exceed \$11,364.25 to Athens Screen Printing for façade improvements. Carmen Hunt seconded the motion and motion carried 6-0.

2. <u>Henderson County HELP Center</u>-This project was approved in last year's round of funding. Project is complete and staff recommends payment of \$600 for lighting improvements.

Will Traxson made a motion, seconded by Cliff Barrett, to approve the grant payment, in the amount of \$600, to Henderson County HELP Center. Motion carried 6-0.

B. Community Development Grant Program

- 1. Committee Chair Traxson presented the recommendations for funding of the 2018 project applications, as follows:
 - A. Athens Teenage Baseball Association, Inc. \$15,000 to cover batting cages and complete significant drainage and landscaping improvements along all fields, at a total estimated cost of \$20,000.
 - B. Henderson County Regional Fair Park \$30,000 to replace 40 equine stalls in the front barn, at a total cost of \$66,636

Motion was made by John Trent to approve the funding recommendations, and seconded by Will Traxson. Motion carried 6-0.

The balance due of \$20,000 will be owner financed by AEDC for a one year term with no interest. John Trent seconded and motion carried 6-0.
