Call to Order

The meeting was called to order at 10:00 a.m. by President Jess Laird for all agenda items. A quorum was present.

Consider discussion and possible approval of minutes from the following AEDC Board Meetings:

A. April 18, 2017

Will Traxson made a motion to approve the minutes from April 18 2017, as presented. Carmen Hunt seconded the motion. Motion passed 5-0.

Will Traxson made a motion to approve the Restated 1st Quarter and the 2nd Quarter Financials, as presented. John Trent seconded. Motion passed 5-0.

- C. April Financials
 - 1. **Revenue** Total revenue for the month of April was \$100,819.98; sales tax accounting for \$97,806.73 of that amount. Sales tax collections were up 5.2% from this time last year. Sales tax collections are up 1.49% for the year. (as of 4/2017)
 - **2.** Expenses Expenses for the month totaled \$63,273.15
 - **3. Balance Sheet -** The Balance sheet shows the corporation has \$2,512,981.42 in liquid assets, as of April 30, 2017
 - **4. Commitments/LTD** AEDC has ED project commitments totaling \$1,408,340 and Long Term Debt Obligations of \$1,947,634.22

Carmen Hunt made a motion to approve the April financials. Jeaneane Lilly seconded the motion. Motion passed 5-0.

D. FDIC and Collateral Risk

This item was tabled until June, in the absence of the Treasurer.

A. Athens Industrial Park:

- 1. Texas Capital Fund Project The Indemnity Agreement has been given to FutureMatrix Interventional for approval and execution.
- Roadway Engineering Design Contract The board was presented with the design options that came as a result of a meeting with city, AEDC and engineer. Plans are designed to manage and lessen wetland issues. Stantec will follow up with Oncor on design options to see which design meets their approval.

Compliance Review of Community Development Grant Program with Henderson County Performing Arts Center

Lisa Denton presented the project completion report received from HCPAC, with Executive Director David Hill on hand to answer any questions. AEDC's 60 day public notice period expires 5/29/17. Ms. Denton informed board that the project could be reviewed and ruled in compliance, but funds could not be expended until after 5/29.

Will Traxson made a motion to rule Henderson County Performing Arts Center project in compliance, and approved grant payment in the amount of \$4802 to be made after 5/29/17. John Trent seconded the motion. Motion carried 5-0.

Update on project to explore Freeport Tax Exemption opportunities with local taxing entities

Athens Chamber of Commerce also provided a letter of support for the program.

John Trent made a motion to approve the contract with Opportunity Strategies LLC for the strategic plan update. Jeaneane Lilly seconded the motion. Motion passed 5-0.
