CONSIDER APPROVING THE MINUTES OF THE MARCH 17, 2016

A motion was made by Member Babb, seconded by Member Grant to approve the minutes of the March 17, 2016 Regular Session.

UPDATE ON AIRPORT MASTER PLAN

Thanasis Kombos, Community Development Manager stated he is preparing a Press Release relating to the Airport Planning Advisory Committee's first meeting. He informed the Board the Press Release has been sent out to five (5) different newspapers in Henderson County.

Mr. Kombos stated TxDOT has performed an Aerial imaginary of the Athens Municipal Airport.

Mr. Kombos informed the Board that he is currently waiting to review the initial content of the report from Garver.

OPPORTUNITY FOR CITIZENS TO EXPRESS ITEMS OF CONCERN
RELATING TO THE CITY OF ATHENS:

Mr. Wayne Addkison asked about the flight plan for the new runway.

Mr. Addkison informed the Board that Cedar Creek Veterans Airshow is scheduled for July 2, 2016.

DISCUSS DEVELOPMENT OF NEW HANGAR

Mr. Kombos stated that Paul Calhoun is requesting to construct a hangar space at Area 1, Lot 5 at Athens Municipal Airport. Mr. Kombos provided a sketch of the proposed hangar space. Mr. Addkison further clarify that approximately 2 years prior, he appeared before the City Council on Paul Calhoun's behalf and the Council approved the construction of Hangar in Area 1, Lot 5.

After further discussion, it was the consensus of the Board that the City Secretary research the approval of the Hangar Construction Application by the City Council and submit the item on a future Airport Advisory Board agenda.

COMMUNITY DEVELOPMENT MANAGER'S UPDATE

Mr. Kombos stated that conventional septic system at Athens Municipal Airport failed, and attempts were made to remedy the situation with repairs and the possibility of an aerobic system.
