A motion was made by Councilmember Gross, seconded by Councilwoman Freeman to approve the Consent Agenda. The motion carried unanimously.

RESOLUTIONS

a) DISCUSS, CONSIDER, AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPROVAL OF A RESOLUTION SELECTING THE NEXT STEP AS OUTLINED IN THE CHARTER WITH REGARDS TO CITIZEN'S INITIATIVE BY PETITION OUTLAWING ABORTION DECLARING ATHENS A SANCTUARY CITY FOR THE UNBORN

Elizabeth Borstad, City Manager, explained the next steps as outlined in the Charter.

The City Council shall either:

- (a) Pass the initiated ordinance without amendment within thirty (30) days after the date of certification to the city council; or
- (b) Submit said initiated ordinance without amendments to a vote of those qualified to vote in city elections in a regular or special election to be held within ninety (90) days after the date of the certification to the city council; or
- (c) At such election submit to a vote of those persons qualified to vote in city elections said initiated ordinance without amendment and an alternative ordinance on the same subject proposed by the city council.

Councilmember Smith stated he agrees with the purpose but expressed concern with the tactics and mechanisms used in pursuit of the petition. Councilmember Smith said Athens is a great place. There are compassionate people in Athens. He further stated that when you have conversations and disagree, at the end of the day; he will still love you.

A motion was made by Councilmember Gross, seconded by Mayor Clay to select option b) Submit said initiated ordinance without amendments to a vote of those qualified to vote in city elections in a regular or special election as the next step as outlined in the Charter with regards to Citizen's Initiative by Petition outlawing abortion declaring Athens a Sanctuary City for the Unborn. The motion carried unanimously.

Mr. Keenon presented the CPI increase requested by Republic Services for residential and commercial customers. Discussion occurred.

The City Council; discussed the 2023 City Manager's proposed budget including the following:

- Paying cash to purchase two (2) new police vehicles

Ms. Borstad stated that the School Resource Officer Agreement (SRO) will appear on the City Council's August 8th agenda.

Ms. Quigg reviewed the City of Athens Cash and Investments as of June 30, 2022.

The City Council discussed the Utility Fund.

Ms. Borstad explained a utility rate increase will occur on October 1, 2022, and a Fee Ordinance will come back to the City Council.

The City Council discussed the Capital/Supplemental Overview worksheet for Utilities Fund.

The City Council discussed the Cain Center Fund and methods to increase the membership.

Discussion occurred regarding the current membership tracking software. Staff received direction to look for an alternative software system.
