CONSIDER ACTION RESULTING FROM DELIBERATIONS IN EXECUTIVE SESSION PURSUANT TO TEXAS GOVERNMENT CODE, SECTION 551.072 (DELIBERATION REGARDING REAL PROPERTY) AND SECTION 551.087 (DELIBERATION REGARDING ECONOMIC DEVELOPMENT NEGOTIATIONS):

A) DISCUSS/CONSIDER LEASE OF REAL PROPERTY LOCATED AT 1702/1704 ENTERPRISE STREET

Lisa Denton, Athens Economic Development Corporation Executive Director explained the AEDC Board approved a lease agreement between AEDC and Future Matrix for property located at 1704 Enterprise at the rate of \$6,500 monthly, with a deposit of \$6,500. A motion was made by Councilmember Montgomery, seconded by Councilmember Elliott to approve the lease of real property located at 1704 Enterprise Street. The motion passed unanimously.

B) DISCUSS/CONSIDER ECONOMIC DEVELOPMENT NEGOTIATIONS WITH PROSPECT #1516

Ms. Denton explained that Future Matrix Interventional has proposed to make capital investments of at least \$600,000 and add at least fifteen (15) new full-time employees in Athens. Ms. Denton stated the expansion of the company will add to the tax rolls of Athens and AEDC has approved incentives in an amount up to \$50,000 for job creation. A motion was made by Councilmember Elliott, seconded by Councilmember Winn to approve economic development negotiations with Prospect #1516. The motion passed unanimously.
