HEAR UPDATE ON CAIN CENTER PROJECT

Elizabeth Borstad, City Manager, stated the bid process for the Cain Center Project has started with a thorough pre-bid meeting on January 23rd at the Cain Center with bids being due back approximately one (1) week later.

Ms. Borstad explained the item is the Park, Prairieville and Clinton water line replacement.

Boyd London, Hilltop Securities, addressed the City Council and explained the history of the Water Development Board. Mr. Boyd further stated the City of Athens received financial assistance from Texas Water Development Board in the amount \$1,125,000 for water system improvements, with \$300,000 in loan principal forgiveness.

Mr. Boyd reviewed the schedule of calendar events relating to "City of Athens, Texas, Waterworks and Sewer System Revenue Bonds, Series 2020".

After a brief discussion, Bonnie Hambrick, City Secretary, read the caption of the Ordinance aloud.

DISCUSS FIRST READING OF ORDINANCE AMENDING THE TOTAL APPROPRIATIONS BUDGET FOR FISCAL YEAR ENDING SEPTEMBER 30, 2020

Mandie Quigg, Finance Director, presented the item and explained the budget amendment is due to the addition of the Crane Truck purchase being added to Fiscal Year 2020 Budget.

Ms. Hambrick read the caption of the Ordinance aloud.
