Councilmember Gross stated he would like to see the Downtown Façade Improvement Program possibly being transferred to AEDC for consideration, as they have much broader guidelines to approve the request.

UPDATE – HENDERSON COUNTY FAIR PARK – [B. MIARS]

Bob Miars, Henderson County Regional Fair Park Board Chairman, presented an update to the City Council regarding the Henderson County Fair Park that included the following:

- Revenues up 24%
- HOT Funds reserved for Capital Improvements
- 35% of Revenue comes from the stalls
- The arena is booked over 51 weekends

UPDATE – DEVELOPMENT SERVICES

Audrey Sloan, Director of Development Services, provided a third quarter update that included the following:

- 4 permits issued for new commercial construction are for a triplex at 413 W College St, a new building for Thrive Church to be located on Old Tyler St behind the Whataburger and a temporary building for Thrive Church at their existing location on US Hwy 175 E.
- 11 Commercial remodel permits which includes phase I of a new addition for HVAC manufacturing located at 1010 W Corsicana St and a restroom addition and fire sprinkler system extension for Biomerics at 1704 Enterprise Dr.
- 2 permits were issued for new duplex construction on Lindsey Lane and on East Clinton St.
- Eight permits were issued for new single-family homes
- 11 permits were issued for manufactured homes; with the new triplex under construction, this represents a total of 26 dwelling units added to the city's housing stock
- 123 MEP permits, 7 fence permits and 21 signage permits issued.
- 17 Certificate of Occupancy permits were issued including three new businesses in the downtown: Deja Bougie Beauty Studio at 209 N Prairieville St. Karabo's Bakery at 410 N Prairieville St, Pink Pineapple Boutique at 206 N Palestine St.
- Certificate of Occupancy issued for WaWa's Seafood Shack at 1408 E. Tyler Street and the newly remodeled Chicken Express located on Flat Creek Rd.
- 12 new townhomes located at 501 & 507 Bryson were completed recently and were issued certificates of occupancy
- Meeting scheduled for October 30th with the developers of the new Woodland Springs residential subdivision on N Wofford St to discuss steps needed to complete the civil phase of the project
- A new developer has bought the Park 19 subdivision which is located south of Hillside Dr. on S Hwy 19/Palestine St.

• TxDOT did not approve the developer's proposed drive approach entry at the light for the Triton Development on E. Tyler St.
