DISCUSS TEMPORARY USE PERMIT SEC. 31-A OF THE ZONING ORDINANCE

Councilmember McCain expressed concern with the City's current Temporary Use Permit having a duration of a 120 days. He stated 120 days is too long for temporary use. He stated this allows an individual to operate for 240 days without a Certificate of Occupancy.

After discussion, staff will research similar cities in size for their types of Ordinances in place and bring a summary back to the City Council.

CONSIDER FINAL READING OF AN ORDINANCE CONCERNING A REQUEST FROM MARK IMMEL FOR APPROVAL OF A SPECIFIC USE PERMIT FOR THE LIGHT MANUFACTURING AND ASSEMBLY OF FORMED RUBBER PRODUCTS FOR LOT 2D, BLOCK 90 OF ATHENS ORIGINAL TOWN, T. PARMER SURVEY A-782, ALSO KNOWN AS 807 WEST CORSICANA STREET

Mayor Montgomery stated there was discussion on the item and he spoke with the proposed owner Mr. Immel regarding the odor. Mayor Montgomery stated the City council could approve the item with a stipulation to review the application in one (1) year to ensure the odor is not causing a nuisance

Councilmember Smith agreed to review the item again in one (1) year and check with the surrounding homeowners.

Councilmember McCain expressed concern in approving the Ordinance with the stipulation of a review after one (1) year. He stated that it does not seem fair to the business owner, as the business could be shut down in a year.

Mr. Immel addressed the City Council and explained the manufacturing process is in an open area and invited the Council to visit the facility.

After discussion, Ms. Hambrick read the caption of the Ordinance aloud.

A motion was made by Mayor Montgomery seconded by Councilmember Smith to approve final reading of an Ordinance concerning a request from Mark Immel for approval of a Specific Use Permit for the light manufacturing and assembly of formed rubber products for Lot 2D, Block 90 of Athens Original Town, T. Parmer Survey A-782, also known as 807 West Corsicana Street with a stipulation that staff review and relook at the operations in one (1) year from the date of approval to ensure there is no excessive odor.
