Elizabeth Borstad, City Manager, provided the following updates:

- Currently the City is still under a boil water notice
- Over 600 meters were turned off due to water leaks
- Staff received positive feedback, on Facebook on how everything was handled

Ms. Borstad thanked the following organizations for their assistance:

- Hope Springs Water for delivering water
- Rebecca Project and Sand Springs Church for providing food
- Katie Birk and Hannigan Media for continuous Facebook updates
- Frank Lunceford for bringing heaters out to the site
- Police and Fire, as they are always on call
- Disciples Crossing for providing shelter
- Street Employees for working non-stop

Mayor Montgomery thanked staff, Hope Springs Water, Oncor, Release Free Church for shelter and all the citizens for their positive input.

Councilwoman Freeman thanked Lance West, Fire Marshal for his assistance during the weather event.

Mayor Montgomery thanked Ms. Borstad for all her hard work. He stated she consistently provided updates to the Council. He stated, "last week was an orchestra and Ms. Borstad was the conductor and she did a great job".

Councilmember Smith expressed appreciation on how the community came together last week during the weather event. He stated "love your neighbor" was seen in action all over the city.

Ms. Borstad stated the water bill due date was extended until February 22, 2021. She stated second notices will be mailed, however no penalties assessed. She stated if citizens have a leak or have used excessive water; leak adjustments can be made by providing a plumber invoice or purchase receipt for parts.

Ms. Borstad stated the Collection Site will be open on February 26, 2021, free of charge for storm related items.

CONSIDER APPROVING MINUTES OF THE FEBRUARY 8, 2021 REGULAR SESSION

A motion was made by Councilmember Smith, seconded by Councilwoman Freeman to approve minutes of the February 8, 2021 Regular Session. The motion carried by the following vote: Ayes: Mayor Montgomery, Councilmember Smith, Councilwoman Freeman, Nays: None Abstain: Councilmember Gross.

DISCUSS, CONSIDER, AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPROVAL OF A RESOLUTION EXTENDING THE DISASTER DECLARATION ISSUED BY THE MAYOR ON FEBRUARY 15, 2021 IN RESPONSE TO THE SEVERE WEATHER EVENT

Ms. Borstad stated on February 15, 2021 following suit of the County; Mayor Montgomery issued a Disaster Declaration. She explained the Disaster Declaration is good for seven (7) days unless extended by the governing body of the City.

Ms. Borstad stated she is requesting Council to extend the Disaster Declaration until it is rescinded by the City Council.

Mayor Montgomery stated he favors extending the Disaster Declaration as some business entities may not know what their damages are and by extending the Declaration; business can still file damages. He stated the Disaster Declaration should remain in place until the city can overcome all obstacles related to the storm.

A motion was made by Councilwoman Freeman, seconded by Councilmember Smith to approve a Resolution extending the Disaster Declaration issued by the Mayor on February 15, 2021 in response to the Severe Weather Event. The motion carried unanimously.

## PRESENTATION OF TOURISM WEBSITE

Katie Birk, Tourism and Cultural Resources Coordinator, presented the Tourism website and displayed the different attractions for visitors. Those attractions included wine tours, restaurants, and different activities to do in the area.

Councilmember Gross asked for the Country Club to be put on the Tourism Website since visitors can visit the Country Club and play golf.
