C) DISCUSS POSSIBLE APPROVAL OF ATHENS ECONOMIC DEVELOPMENT CORPORATION'S BUSINESS ASSISTANCE GRANT PROGRAM APPLICATION SUBMITTED BY ATHENS SCREEN PRINTING

Lisa Denton, Executive Director of Athens Economic Development Corporation explained Athens Screen Printing has purchased the building at 112 N. Palestine and is seeking the Business Assistance Grant to do sign work, painting and door replacement.
