Mayor Montgomery presented a proclamation proclaiming the month of May as "Building Safety Month".

• Councilwoman Clay announced the Open House for the Athens High School gymnasium and cafeteria is scheduled for Thursday, May 17, 2018 from 4:00-6:00 p.m. She stated this is also an opportunity to meet the new incoming Principal, Mr. Clay Tracy

Mayor Montgomery stated he read a Proclamation honoring J. B. Henry at a dedication ceremony on Saturday, May 12, 2018. He stated Mr. Henry invented the process to take weebles out of Black-eyed peas which lead to Athens becoming known as the Black-eyed Pea Capital of the World.

DISCUSS, CONSIDER AND TAKE ACTION, AS NECESSARY, REGARDING CANCELING THE MAY 28, 2018 REGULAR SESSION

Ms. Borstad explained that May 28, 2018 is a holiday and the recommendation is to cancel the May 28, 2018 City Council Regular Session. A motion was made by Councilmember McCain, seconded by Councilmember Gross authorizing the cancellation of the May 28, 2018 Regular Session due to the holiday. The motion carried unanimously.

UPDATE ON GIANT SALVINIA – LAKE ATHENS PROPERTY OWNERS ASSOCIATION

Mayor Montgomery stated the item is pulled from the agenda and there was no discussion.

DISCUSS, CONSIDER AND TAKE ACTION, AS NECESSARY, CONCERNING COMMISSIONING CHARLIE BULLOCK TO PAINT AN INTERIOR MURAL AT THE TEXAN

Thanasis Kombos, Assistant City Manager, stated that Charlie Bullock was appointed to The Texan Design Committee and has been involved and instrumental in the design process of The Texan from the beginning. He stated Mr. Bullock has approached the City and would like to commission a mural inside the space.

Mr. Bullock presented paint options of an interior mural on the east wall of the mezzanine which would represent the many years the Texan was open over the years of 1948-1984. He stated he would paint four (4) different posters for \$2,000.

Discussion occurred.

Mayor Montgomery expressed concern with the mural project. He stated he'd like to see a local artist have his mark on The Texan Theater, however, one of the issues he has is the expenses incurred during The Texan renovation, such as the Audio Visual and the last phase of expenses.

Councilmember McCain stated he was worried that the City does not know what the venue will evolve into. He further stated his concerns that if someone was planning a wedding the paintings could be a distraction

Councilwoman Clay stated a mural in the mezzanine would not likely be an easy thing to see from the floor.

The item died due to the lack of a motion.

PRESENTATION OF COMPLETE CONSTRUCTION DOCUMENTS AND ASSOCIATED COST ESTIMATES FOR THE CAIN CENTER PROJECT

Mr. Kombos stated this is the final presentation prior to bidding the project. He stated there were no changes to the design; simply moved a few things around.

Jeff Bulla, of PGAL Architects, said the construction documents were presented to Gallagher Construction last week.

Bill Morgan, of Gallagher Construction stated bid packages were prepared for all elements of the project and went out to 4000-5000 contractors to look at; with an in-house list of 1000 contractors that were personally invited to bid the project.

He presented the updated cost estimates for the Cain Center Project and reviewed the proposed schedule.

PRESENTATION OF ATHENS ECONOMIC DEVELOPMENT CORPORATIONS' FIVE YEAR STRATEGIC PLAN – FINAL REPORT

Lisa Denton, Executive Director, Athens Economic Development Corporation, (AEDC) presented AEDC's five (5) year Strategic Plan – Final Report.

Mr. Kombos informed the Council that this T-Hangar was vacated and the wait list was exhausted. Mr. James Dippel contacted Staff and expressed interest in leasing the T-hangar.

A motion was made by Councilmember McCain, seconded by Councilmember Gross to approve lease agreement with James Dippel for T-Hangar No. 8 at Athens Municipal Airport. The motion carried unanimously.
