A motion was made by Councilmember Whatley, seconded by Councilmember Winn to approve the Consent Agenda. The motion carried unanimously.

DISCUSS/CONSIDER REQUEST TO CLOSE A PORTION OF OWEN STREET ON SATURDAY, MAY 30, 2015 FROM 10:00 A.M. UNTIL 11:00 P.M. FOR CHARITY EVENT FOR DISASTER RELIEF FOR VAN, TEXAS, AS REQUESTED BY D.J. ALLEN ATHENS FARMERS MARKET

Rachelle Bright explained that Athens Farmers Market is requesting authorization to close a portion of Owen St., on 5/30/15 from 10:00 a.m. to approximately 11:00 p.m. for a disaster relief benefit concert for Van, Texas.

Buddy Hill, Chief of Police further explained the closure is from the intersection of Dull Averiette St. and a portion of Owen St. and the Farmers Market group is prepared to purchase the insurance policy upon Council's approval. He recommends making the motion contingent upon the purchase of insurance.

A motion was made by Councilmember Montgomery, seconded by Councilmember Elliott to authorize the closure of Owen Street on Saturday, May 30, 2015 from 10:00 a.m. until 11:00 p.m. for a charity event for disaster relief for Van, Texas, contingent upon the purchase of insurance. The motion carried unanimously.

DISCUSS/CONSIDER AUTHORIZING THE CLOSURE OF PRAIRIEVILLE STREET AND TYLER STREET AND APPROVE RESOLUTION AGREEMENT WITH TXDOT FOR THE TEMPORARY CLOSURE OF STATE RIGHT-OF-WAY FOR THE 84TH OLD FIDDLERS REUNION

Chief Hill explained Texas Department of Transportation (TxDot) regulations now requires a Resolution when requesting the closure of State Right-of-Way and the Resolution must state it serves a public purpose. A motion was made by Councilmember Elliott, seconded by Councilmember Winn

authorizing the closure of Prairieville Street and Tyler Street and approve a Resolution Agreement with TxDot for the temporary closure of State Right-of-Way for the 84th Old Fiddlers Reunion. The motion carried unanimously.

DISCUSS/CONSIDER AUTHORIZING THE CLOSURE OF PRAIRIEVILLE STREET AND TYLER STREET AND APPROVE RESOLUTION AGREEMENT WITH TXDOT FOR THE TEMPORARY CLOSURE OF STATE RIGHT-OF-WAY FOR THE POST JUNETEENTH PARADE FESTIVITIES, AS REQUESTED BY HENDERSON COUNTY BLACK RODEO ASSOCIATION (HCBRA)

Chief Hill explained TxDot requires a Resolution when requesting the closure of State Right-of-Way stating the closure serves a public purpose. A motion was made by Councilmember Winn, seconded by Councilmember Elliott authorizing the temporary closure of State Right-of-Way for the post Juneteenth Parade festivities, as requested by Henderson County Black Rodeo Association (HCBRA). The motion carried unanimously.
