PUBLIC HEARING ON PROPOSED TAX RATE FOR FISCAL YEAR 2022

Mandie Quigg, Finance Director, presented the proposed Tax Rate for Fiscal Year 2022. She explained the City is required to hold one (1) Public Hearing. She stated the proposed tax rate is Maintenance and operations plus the debt service. Total Rate = \$0.645221/\$100 is a reduction to total tax rate by \$0.015 cents.

Mayor Clay opened the Public Hearing.

DISCUSS, CONSIDER, AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPROVAL OF A RESOLUTION CONCERNING A REQUEST FROM GERALD SPIVA OF HALLOWED GROUNDS HAUNT PARK FOR A VARIANCE FROM THE REGULATIONS IN CHAPTER 22, ARTICLE III, SECTION 22-31A THE CODE OF ORDINANCES CONCERNING THE MAXIMUM DURATION FOR A TEMPORARY USE PERMIT. THE APPLICANT IS REQUESTING A VARIANCE TO OPERATE A HAUNTED HOUSE WITH A WAX MUSEUM, COMMERCIAL VENDORS AND FOOD VENDORS AT 2705 WEST STATE HIGHWAY 31 FROM THE HOURS OF 7:00 PM TO 12:00 AM FROM OCTOBER 1 – 31, 2021

Ms. Sloan stated Mr. Spiva is proposing to have a haunted house event for ten (10) days. She stated the temporary use permit specifies it should not exceed seven (7) days.

Mr. Spiva stated he has held this event for three (3) years in Malakoff and Canton.

The applicant is requesting a variance to operate a haunted house with a wax museum, commercial vendors, and food vendors at 2705 West State Highway 31 from the hours of 7:00 p.m. to 12:00 a.m. from October 1-31, 2021.
