DECLARATION OF CONFLICT OF INTEREST

No action was taken.

FIRST PUBLIC HEARING ON TAX INCREASE FOR FISCAL YEAR 2014-2015

Mayor Vaught opened the Public Hearing on Tax Increase for fiscal year 2014-2015. There was no discussion from the public and the public hearing was closed.

DISCUSS/CONSIDER ATHENS ECONOMIC DEVELOPMENT CORPORATION'S BUDGET FOR FISCAL YEAR 2014-2015.

Brian Malone presented the Athens Economic Development Corporation's (A.E.D.C.) budget for fiscal year 2014-2015. There was no discussion. A motion was made by Councilmember Elliott, seconded by Councilmember Whatley to approve the A.E.D.C.'s budget for fiscal year 2014-2015. The motion carried unanimously.

DISCUSS/CONSIDER ATHENS ECONOMIC DEVELOPMENT CORPORATION'S INCENTIVE PACKAGE FOR STERITEC, INC. AND APPROVING PERFORMANCE AGREEMENT.

Mr. Malone presented A.E.D.C.'s incentive package for Steritec, Inc. After discussion, a motion was made by Councilmember Winn, seconded by Councilmember Elliott to approve the Incentive Package and Performance Agreement for Steritec Inc., as presented. The motion carried unanimously.

PUBLIC HEARING CONCERNING REZONING OF LOT 55D, T. PARMER SURVEY FROM INDUSTRIAL TO COMMERCIAL, OWNED BY LUMBERJACK PARTNERS LLC (1220 S. PALESTINE ST.).

Gary Crecelius, Director of Planning & Development, explained that the owner of this property has closed their business and is requesting the property be rezoned back to Commercial. He further explained 14 letters were mailed to surrounding property owners and no responses were received. The Public Hearing was closed.

CONSIDER FIRST READING OF AN ORDINANCE REZONING OF LOT 55D, T. PARMER SURVEY FROM INDUSTRIAL TO COMMERCIAL, OWNED BY LUMBERJACK PARTNERS LLC (1220 S. PALESTINE ST.).

Ms. Cox read the Ordinance aloud. Motion was made by Councilmember Whatley, seconded by Councilmember Winn to approve FIRST READING OF AN ORDINANCE REZONING LOT 55D, T. PARMER SURVEY FROM INDUSTRIAL TO COMMERCIAL. The motion carried unanimously

DISCUSS/CONSIDER ANGELINA & NECHES RIVER AUTHORITY NECHES COMPOST FACILITY BUDGET FOR FISCAL YEAR 2015.

Glen Herriage, Director of Utilities presented the budget for Angelina & Neches River Authority Neches Compost Facility for fiscal year 2015. Mr. Herriage explained the City's increase will be 2.2%.

City Administrator, Pam Burton explained to the Council that the City Attorney had reviewed the Contract. After discussion, a motion was made by Councilmember Whatley, seconded by Councilmember Winn to table this item. The motion carried unanimously.

DISCUSS/CONSIDER RENEWAL OF PROPERTY/LIABILITY/WORKERS' COMPENSATION INSURANCE.

Ms. Burton updated the Council of Staff's recommendation to renew Property/Liability/Workers' Compensation Insurance with Texas Municipal League (TML) on 10-01-14, explaining that the City will be adding the Cain Center to the property insurance at an additional amount of \$8,093. A motion was made by Councilmember Whatley, seconded by Councilmember Elliot to renew the property/liability/workers compensation insurance with TML adding the Cain Center, as presented. The carried unanimously.

DISCUSS/CONSIDER BIDS RECEIVED FOR REMOVAL OF SLUDGE FROM SURFACE WATER PLANT LAGOONS AND DISPOSAL TO SLUDGE DISPOSAL SITE OWNED BY ATHENS MUNICIPAL WATER AUTHORITY.

Mr. Herriage presented bids for the removal of sludge and recommended the bid be awarded to low bidder, Terra Renewal, at a cost of 0.038 per gallon. A motion was made by Councilmember Whatley, seconded by Councilmember Winn to award the bid for removal of sludge from surface water plant lagoons and disposal to sludge disposal site owned by Athens Municipal Water Authority to Terra Renewal at a cost of 0.038 per gallon. The motion carried unanimously.

DISCUSS/CONSIDER BIDS RECEIVED FOR ONE (1) NEW 2015 MODEL ½-TON PICKUP FOR USE IN WASTEWATER TREATMENT DEPARTMENT.

Mr. Herriage presented the bids received for the new 2015 Model ½-Ton Pickup for use in Wastewater Treatment Department. After discussion, a motion was by Councilmember Winn, seconded by Councilmember Elliott to award the bid for the 2015 Model ½ Ton Pickup to the low bidder, Caldwell Country Chevrolet, at the cost of \$19,893.00. The motion carried unanimously.

DISCUSS/CONSIDER REQUEST FOR PROPOSALS RECEIVED FROM EXECUTIVE SEARCH FIRMS FOR CITY ADMINISTRATOR POSITION.

Ms. Burton informed the Council that four (4) proposals were received from Executive Search Firms for the City Administrator Position consisting of: The Austin Peters Group, Inc. at a cost of \$12,000-\$17,000 plus expenses; Chris Hartung Consulting LLC at a cost of \$14,000 base plus expenses; Strategic Government Resources at a cost of \$18,500 plus \$8,500 expenses; Affion Public, LLC at a cost of \$21,000. After discussion, it was determined that Chris Hartung and Strategic Resources would be invited to make formal presentations at next Council meeting.
