Councilmember Gross thanked the Athens Economic Development Corporation's Board of Directors for adding \$230,000 to the infrastructure line item. He expressed concern with the following items within Athens Economic Development's Budget for Fiscal Year 2020:

- \$40,000 for the Community Development Projects
- \$50,000 for the Business Assistance Grants

Councilmember Gross stated he would like to see those funds in the line item for infrastructure for future business growth.

Discussion occurred regarding the allocation of those line items within AEDC's budget.

After discussion a motion was made by Councilmember Gross, seconded by Mayor Montgomery to reallocate the 50,000 for the Business Assistance Grants and \$40,000 for the Community Development Projects line items from the Fiscal Year 2020 Budget and remain as unallocated funds.

The motion carried by the following vote: Ayes: Mayor Montgomery, Councilmember Gross, Councilmember Smith, Nay: Councilwoman Clay.

## i) CONSIDER A RESOLUTION AUTHORIZING THE CITY MANAGER TO INCREASE THE CITY'S EMERGENCY RESERVE

Mayor Montgomery stated it was impressive that the City of Athens is able to increase the City's Emergency Reserve.

Mandie Quigg, Finance Director, explained the Transfer from General Fund is \$370,000 which will increase the City's Emergency Reserve from 65 days to 75 days of operating expenditures.

Ms. Borstad explained the City may have an opportunity to add more days to the emergency reserve mid-way through the year.

A motion was made by Councilmember Gross, seconded by Councilmember Smith to approve a Resolution authorizing the City Manager to increase the City's Emergency Reserve. The motion carried unanimously.

#### HEAR UPDATE ON CAIN CENTER PROJECT

Mayor Montgomery stated a pre-construction meeting was held on 9/5/19. He stated the construction mangers at risk and sub-contractors attended the meeting. He stated the contractors were able to walk through the facility.
