DISCUSS/CONSIDER CANCELING DECEMBER 17, 2014 SPECIAL SESSION AND DECEMBER 22, 2014 REGULAR SESSION

City Administrator Pam Burton recommended that the December 17, 2014 Special Session and December 22, 2014 Regular Session be canceled. She explained the December 22, 2014 Regular Session is during the week of the Christmas Holiday and by canceling this meeting it is not necessary to have the December 17, 2014 Special Session. A motion was made by Councilmember Elliott, and seconded by Councilmember Whatley to cancel the December 17, 2014 Special Session and December 22, 2014 Regular Session. The motion carried unanimously.

DISCUSS ITEMS FOR FUTURE AGENDAS;

A) DISCUSS AUTHORIZING PURCHASE OF FULL SIZE SUV FOR USE IN FIRE DEPARTMENT

Fire Chief, John McQueary informed the Council that he is seeking authorization to purchase full size SUV from State Bidders List. He explained that Caldwell Country is within the budgeted amount with a cost of \$28,155. The item will appear on the agenda Monday, December 8, 2014.

B) DISCUSS PROPOSALS FOR QUALIFIED ENGINEERING FIRMS TO DESIGN WATER LINE IMPROVEMENTS ON S. PRAIRIEVILLE ST, PARK ST., AND E. CLINTON

Councilmember Montgomery explained the Committee consisting of Councilmember Whatley, Councilmember Montgomery and Glen Herriage reviewed and rated the 6 proposals for qualified engineer firms. Velvin and Weeks and Hayter Engineering Firm are rated one and two respectively. Councilmember Montgomery stated that both companies interviewed well; however the best firm for the City is Velvin and Weeks. The item will appear on the agenda Monday.

C) DISCUSS INCREASE IN HOTEL/MOTEL TAX

Councilmember Whatley expressed his feelings regarding options to provide funds for the Cain Center, and an increase in the Hotel/Motel tax rate from 7% to 9% could provide those funds.
