The Invocation was given by Mayor Monte Montgomery.

The Pledge of Allegiance was recited.

DECLARATION OF CONFLICT OF INTEREST

No action was taken.

MAYOR, CITY COUNCIL AND/OR CITY MANAGER UPDATES INVOLVING COMMUNITY EVENTS AND ISSUES OF PUBLIC SAFETY

Elizabeth Borstad, City Manager stated the architects are comparing the City's plans with the plans the Cain Center Steering Committee submitted. She also stated the next step is to issue a request for proposals for a Construction Manager at Risk.

Mr. John Trent presented the item.

Councilmember Gross requested clarification on the requirements of the loan documents. After discussion; Ms. Borstad stated she would meet with Councilmember Gross and Mr. Trent to further discuss the requirements.

Bonnie Hambrick, City Secretary, read the caption of the Resolution aloud.

DISCUSS, CONSIDER AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPOINTMENT OF A NEW BOARD MEMBER TO FILL VACANCY ON THE ATHENS ECONOMIC DEVELOPMENT CORPORATION BOARD OF DIRECTORS

Mayor Montgomery explained the vacancy is to fill the unexpired term of Jeaneane Lilly. Will Traxson provided background information for Mr. Morgan Jones.

A motion was made by Mayor Montgomery, seconded by Councilmember Smith to appoint Morgan Jones as a new board member to fill vacancy on the Athens Economic Development Corporation Board of Directors. The motion carried unanimously.

DISCUSS, CONSIDER, AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPROVAL OF A BONUS TO FORMER ATHENS ECONOMIC DEVELOPMENT CORPORATIONS' EXECUTIVE DIRECTOR

John Trent presented the item and explained at the last Athens Economic Development Corporation's Board meeting, the Board voted to pay a bonus to Executive Director Lisa Denton for services rendered. He explained it is a discretionary bonus.

Will Traxson stated the Board decided on a discretionary bonus rather than waiting until 2021 for the assessed values for capital improvements.

Mayor Montgomery asked for Legal Counsel regarding the discretionary bonus.

Blake Armstrong, City Attorney, explained under Texas Government Code 551.071 the City Council can convene in Executive Session to receive legal consultation from the City Attorney.

Mayor Montgomery announced the City Council would convene in Executive Session Pursuant to Texas Government Code 551.071.

The City Council adjourned to Executive Session at 5:45 p.m.

The City Council returned to Special Session at 6:04 p.m.

Mayor Montgomery stated the City Council requested legal counsel regarding the discretionary bonus. He further stated the contract does not require the Council to pay a discretionary bonus.

Mr. Armstrong explained that it is a discretionary bonus. He further stated he has reviewed the contract and there are no requirements within the contract that obligates the City Council to make the bonus payment.

Mayor Montgomery entertained a motion to approve a bonus to former Athens Economic Development Corporations' Executive Director.

The item died due to the lack of a motion.

Leslie Saunders, Director, Henderson County Help Center, requested funding in the amount of \$5,000 for assistance with water and electrical bills through the United Way HELP Line.

Michelle Zenor, Director Henderson County Clint W. Murchison Memorial Library requested funding in the amount of \$15,000 for library services and programming.
