INVOCATION.

The Invocation was given by Mayor Clay.

PLEDGE OF ALLEGIANCE

PUBLIC COMMUNICATIONS

There was no discussion.

Kiwana Hurd stated she was in full support of the new police station; however, not in its current location. She stated she did not want a multimillion-dollar facility surrounded by poverty.

DISCUSS, CONSIDER, AND TAKE ACTION, AS NECESSARY, CONCERNING THE SELECTION OF A PROPOSED SITE LOCATION FOR THE CITY OF ATHENS POLICE DEPARTMENT'S NEW POLICE STATION

Elizabeth Borstad, City Manager, stated staff was charged with finding the best location for the proposed police station. She stated recommendations were received from the City Council. She stated Councilmember Gross would like the facility to be visible.

Ron Hobbs of Ron Hobbs Architecture & Interior Design, LLP presented six (6) possible locations and explained both advantages and disadvantages of each property location.

Mr. Hobbs stated while looking at each location he was protective of the budget and the type of impact buying property would have on the budget.

The following locations were presented and discussed:

- W. Corsicana Street adjacent to O'Reilly Auto Parts (3.82 acres)
- E. Tyler Street across from City Hall (3.63 acres)
- E. Tyler Street adjacent VeraBank (4.62 acres)
- Pinkerton Street (3.32 acres excluding PD)
- N. Palestine Street (2.011 acres)
- County owned on Highway 175 (acreage TBD)

After much discussion and questions being answered throughout Mr. Hobbs' presentation, a motion was made by Mayor Clay, seconded by Councilwoman Freeman, to exclude the locations on W. Corsicana Street both locations on E. Tyler, and N. Palestine Street and the locations on Pinkerton St. and Hwy 175, are being considered with authorization given to the City manager to move forward with a preliminary site survey on the Hwy 175 property. The motion carried unanimously.
