CALL TO ORDER

The meeting was called to order by Mayor Monte Montgomery.

The City Council recessed at 12:00 p.m.

The City Council reconvened in Work Session at 12:15 p.m.

DISCUSS COLLECTION SITE

Mayor Montgomery stated the item was presented to the City Council for consideration to close the Collection Site and provide curbside pickup for an extra fee or leave the site opened. Mayor Montgomery stated several constituents have come forward wanting to leave the Collection Site open.

Elizabeth Borstad, City Manager, asked Ryan Adams, Managing Director of Public Services, to refresh the City Council with his presentation regarding the Collection Site.

Mr. Adams presented two (2) current options for Bulk Garbage:

Dispose at City Collection Station

- Open Saturdays from 8:30 AM 3:30 PM
- Accepts residential waste with proof of residency
- Rates generally lower DOES NOT COVER FULL COST

Dispose at County Waste Stations

- Open Weekdays and Saturday
- Rates generally higher
- Takes all refuse

He further presented the four (4) challenges with the Collection Station:

- Regulatory Requirements
- Cost Recovery
- Restriction Management
- Limited Access

Mr. Adams stated the cost to run the collection site is \$55,500 per year and last year it only brought in approximately \$14,201.

There was discussion regarding the regulatory requirements and associated cost.

Mandie Quigg, Director of Finance, reviewed current Collection Site budget and revenues.

Shannon Easley, Parks Superintendent, explained current issues with Saturday staffing.

Councilmember Gross expressed concerns regarding liability issues.

Additional discussion occurred.

After discussion, the City Council directed Staff to provide recommendations to increase the price and at a very minimum reduce the subsidy in half. Further direction was given to keep the Collection Site open for now and review cost increase and move forward from there.

Councilmember Smith requested that the item be revisited in a year.
