ELECTION OF OFFICERS

A motion was made by Member Autry, seconded by Member Wilmeth to re-elect Steve Barksdale as Chair and Paul Ingram as Vice-Chair of the Planning Commission. The motion carried unanimously.

CONSIDER APPROVING THE MINUTES OF THE JANUARY 2, 2018, REGULAR SESSION.

A motion was made by Member Wilmeth, seconded by Member Ingram to approve the January 2, 2018 minutes. The motion carried unanimously.

PUBLIC HEARING CONCERNING A REQUEST FROM JOSE ARICIAGA FOR A 2.34 ACRE ZONE CHANGE FROM SINGLE FAMILY (SF-7), MULTI-FAMILY-2 (MF-2) AND MULTI-FAMILY -4 (MF-4) TO MULTI-FAMILY -5 (MF-5) TO ALLOW FOR SINGLE AND MULTI-FAMILY UNITS AT 205 FRIZZELL STREET (Z-02-18-001).

Barbara Holly, Managing Director of Planning and Development, presented the various aspects of the proposed zone change. Ms. Holly stated that Mr. Ariciaga has built his home on one of the lots, built duplexes on the adjacent lots and plans to continue building more units with the zone change.

Mr. Ariciaga, property owner, was present and showed a display of where the future units are to be built on the properties.
