The meeting was called to order by Chairman Barksdale.

CONSIDER APPROVING THE MINUTES OF THE OCTOBER 1, 2018 REGULAR SESSION.

A motion was made by Member Autry and seconded by Member Wilmeth to approve the October 1, 2018 minutes as written. The motion carried unanimously.

PUBLIC HEARING CONCERNING A REQUEST FROM FIRST HYBIRD INC., PS PLAN FOR THE APPROVAL OF THE REPLAT OF LOTS 15, 16 & 17, COUNTRY CLUB PLACE CREATING LOTS 15-R, 16-R & 17-R, COUNTRY CLUB PLACE PHASE I ADDITION (P-11-18-001)

Chairman Barksdale opened the public hearing. Ryan Adams, Interim Director of Development Services, informed the Commission the requested replat will expand the size of Lot 16 and reduce the size of Lots 15 and 17. Adams stated the new lots will continue to conform to their respective zoning designation of Single Family-10 (SF-10). Adams added that any expansion of the legal non-conforming use on Lot 16 will require a zoning action. Robert Gross ask if the minimum square footage requirements for the homes would change. Steve Grant, agent for applicant, responded that the deed restrictions requirements will not change. Chairman Barksdale closed the public hearing.

Chairman Barksdale opened the public hearing. Adams stated the proposed replat, located at 1303 Flat Creek Road (Chicken Express), is relocating the property line in between two existing lots. Adams added that the Chicken Express site (Lot 121) will increase in size in order to accommodate for a new parking lot layout. The new lots will conform to the requirements of their respective zoning designation which is Commercial (C).
