ORDINANCE 0-94-19

AN ORDINANCE OF THE CITY OF ATHENS, TEXAS, AMENDING CHECK CASHING SERVICES AND LOAN AGENCY REGULATIONS FOUND IN SECTION 32.9 OF THE OF THE CITY OF ATHENS ZONING CODE

WHEREAS, heretofore, on the 5th day of August 2019 the Planning Commission of the City of Athens, Texas after due notice and hearing did hereby recommend approval of the amendments below;

That the use of "Check Cashing Service and Loan Agency" found in Section 32.9 of the City of Athens Zoning Code is amended as shown below. For clarity, text to be removed is struck through and new text is in italics. All changes are highlighted.
