## **ORDINANCE NO. 2020-O-086**

## AN ORDINANCE AMENDING ORDINANCE O-102-19, THE TOTAL APPROPRIATIONS BUDGET FOR FISCAL YEAR ENDING SEPTEMBER 30, 2020; PROVIDING A REPEAL AND SEVERABILITY CLAUSE; PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, on September 9th, 2019, the Athens City Council approved its Budget Ordinance for the 2020 Fiscal Year; and

WHEREAS, pursuant to the City Charter, the City Council has the power to amend any unencumbered funds or appropriations by fund; and

**WHEREAS**, since the adoption of the Fiscal Year 2020 Budget, additional budget appropriation is necessary to provide for unanticipated expenditures not included in the adopted budget; and

**WHEREAS**, the City Council finds it in the public interest to amend the total Fiscal Year 2020 Budget by adding an additional \$2,485,489 to budgeted expenditures;

**WHEREAS**, the first reading of said Ordinance was conducted at a regular meeting of City Council on September 14, 2020 per the City's Charter Article III, Section 3.11.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS:

<u>Section 1.</u> The findings and recitations set out in the preamble to this Ordinance are found to be true and correct, and they are hereby adopted by the City Council and made a part hereof for all purpose.

<u>Section 2.</u> The City Council hereby authorizes an amendment in the amounts listed below to the total appropriations as outlined incorporated herein for all intents and purposes.

<u>Section 5.</u> This Ordinance shall be and become effective from and after its adoption and publication in accordance with the provisions of the Charter of the City of Athens, Texas.
