Daniels Conference Room of the Athens Partnership Center, 201 West Corsicana St., Athens, Texas, via Facebook Live in order to advance the public health goal by avoiding social gatherings in groups of more than 10 people to slow the spread of the Coronavirus (COVID-19) [There will be no public access to the location described above.] with the following members present to-wit:

No action was taken.

MAYOR, CITY COUNCIL AND/OR CITY MANAGER UPDATES INVOLVING COMMUNITY EVENTS AND ISSUES OF PUBLIC SAFETY

Mayor Montgomery provided the following updates:

- Stated everyone is aware of the Coronavirus and the issues and challenges No known cases of COVID-19 in the County or the hospital
- Proud of business owners; they took it upon themselves during the first notices and began taking precautions (working from home, closing areas of groups meetings including churches and restaurants.
- Sacrifices being made by everyone; was informed by fast food restaurants they are down by 30% in sales

Councilmember McCain extended thanks to Judge Wade McKinney for his leadership during the COVID-19 Pandemic. He stated his communication should be commended.

Councilmember Smith thanked the citizens and stated they are adapting to the changes.

Elizabeth Borstad, City Manager, announced the following:

- Municipal Court canceled until April 9, 2020
- Lobby at City Hall closed to the public, however, can pay utility bills online or at drive through
- Utility billing has suspended cut-offs and suspended late penalty on overdue bills

- Permit office lobby will remain open at this time. Public access will be restricted to the lobby only. Offering credit card payment as an option
- Trash collection Beginning March 31 recycling will not be taken to the recycling center. It will be taken to the landfill. This change is being made for two reasons:
  - 1. Refuse for recycling has to be handled by employees. By eliminating this it lowers the chance for the spread of COVID-19.
  - 2. Because people are home more right now there has been an increase in the amount of refuse, so the recycling trucks are being used to pick up regular trash.

Councilmember McCain stated he would like to be very clear regarding water cut off suspension, he stated the meter is running and the customers will be charged for the water service and everything in arrears will have to be paid.

#### PUBLIC COMMUNICATIONS

Bonnie Hambrick, City Secretary, read aloud the following emails received at City Hall.

Dear Athens City Council,

Given the shortage of protective medical supplies across the nation/world, are there any pending economic development projects (or projects which can be implemented quickly) to bring more medical manufacturing to Athens?

Furthermore, when the dust settles on this crisis, US manufacturing of critical supplies/pharmaceuticals (among other things) will likely result, so think it appropriate to consider how Athens can further be branded as the go to location in the central US.

Thanks for your service.

Melissa Baldwin, I work at one of the stores in Athens, one of the biggest things I'm seeing is people from out of town coming in and buying supplies. These are people where the virus is at, like Dallas.

How can we ensure people of Athens are getting supplies they need and how can we be sure the people from other cities are not bringing the virus to our town?

A motion was made by Councilwoman Clay, seconded by Councilmember McCain to approve the Consent Agenda. The motion carried unanimously.

#### HEAR UPDATE ON CAIN CENTER PROJECT

Ms. Borstad explained meetings with Berry and Clay Construction have transpired over several occasions looking at bids received for the Cain Center project. She stated bids were reviewed and Berry and Clay was asked to sharpen the pencils (review the costs). She stated Eric Berry has a proposal for the Council to review. Ms. Borstad stated the next item is for Council to approve a guaranteed maximum price for construction of the City of Athens Civic and Aquatic Center.

Eric Berry, Berry and Clay Construction presented a proposal for a guaranteed maximum price for construction of the City of Athens Civic and Aquatic Center as revised on March 23, 2020.

Mayor Montgomery stated meetings with Berry and Clay were held to discuss Value Engineering. He stated the changes are cost effective.

Councilmember Gross asked that the cost for the HVAC system be reviewed. There was further discussion.

Mr. Berry review the allowances for the following contingencies:

Owners Contingency \$75,000 Contractor Contingency \$75,000 Commemorative Plaque Allowance \$3,500

#### Discussion occurred.

Councilwoman Clay stated this has been a long process, however the process has led to a total of \$5 Million dollars being contributed by two (2) families. It is worth the wait.

Councilmember Smith stated at the end of this project he would like the total project cost on the city's website, so everyone could see what was spent, as well as the 15 year debt services on principle and interest, in-kind service provided by the city and the operational subsidy. He stated this will allow citizens to see the investment they are making on the Cain Center Project.

Mayor Montgomery asked Ms. Borstad to obtain an assurance letter from the Cain Foundation regarding \$2.5 million contribution.

Mayor Montgomery asked Mr. Berry the completion timeframe for the project, with Mr. Berry stating 12-14 months.

DISCUSS, CONSIDER AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPROVAL OF A RESOLUTION AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH BERRY AND CLAY CONSTRUCTION FOR A GUARANTEED MAXIMUM PRICE OF \$7,590,016.26 FOR CONSTRUCTION OF THE CITY OF ATHENS CIVIC AND AQUATIC CENTER

A motion was made by Mayor Montgomery, seconded by councilmember Gross to approve a Resolution authorizing the City Manager to enter into a contract with Berry and Clay Construction for a guaranteed maximum price of \$7,415,425.66 contingent upon the following the stipulations:

- 1. The project is contingent upon the Cain Foundation's \$2.5 Million Contribution
- 2. A change in the contract is allowed if the Cain Foundation does not contribute the \$2.5 Million, the project will discontinue and construction stopped, and the City of Athens shall pay Berry and Clay Construction for services rendered through the date of the stop work order.

The motion carried unanimously.

DISCUSS POSTPONING THE CITY OF ATHENS GENERAL ELECTION SCHEDULED TO BE HELD ON SATURDAY, MAY 2, 2020 UNTIL TUESDAY, NOVEMBER 3, 2020

Mayor Montgomery explained due to the pandemic the Govern has given notice to avoid social gatherings of more than 10 people and to have 6 foot separation. He stated the item is to discuss postponing the City of Athens General Election scheduled to be held on Saturday, May 2, 2020 until Tuesday, November 3, 2020.

Ms. Hambrick read an email from Sytonia Freeman regarding postponing the City of Athens General Election scheduled to be held on Saturday, May 2, 2020 until Tuesday, November 3, 2020.

I would like it to be on record that I don't want it in November, but since I might not have a choice, I'm okay. I'm ready to serve but it may not be my time to serve. What God has for me is for me.

Councilmember Gross stated the city should error on the side of caution.

Ms. Hambrick read the following list of cities postponing their May 2, Election:

Canton Gladewater Belton Hitchcock Joshua Pflugerville White Oak Poteet

Kilgore, LaPorte, Longview and Ore City pending City Council action.

Mayor Montgomery stated he respects Mrs. Freeman's request. He further acknowledged the CDC's request for safety.

Discussion occurred.

A motion was made by Councilmember Smith, seconded by Councilmember Gross to approve a Resolution postponing the May 2, 2020 City of Athens General Election to November 3, 2020. The motion carried unanimously.

DISCUSS, CONSIDER AND TAKE ACTION, AS NECESSARY, CONCERNING THE APPROVAL OF A RESOLUTION EXTENDING THE CITY OF ATHENS DISASTER DECLARATION ISSUED ON MARCH 19, 2020 DUE TO THE IMMINENT THREAT TO PUBLIC HEALTH AND SAFETY AS A RESULT OF THE SPREAD OF THE CORONAVIRUS (COVID – 19), EPIDEMIC, AS DECLARED BY THE WORLD HEALTH ORGANIZATION AS A PANDEMIC ON MARCH 11, 2020

Ms. Borstad explained the Resolution will extend the City of Athens Disaster Declaration issued on March 19, 2020 and it adds a penalty clause into the declaration of a fine not to exceed \$1,000, confinement in jail for a term not to exceed 189 days, or both fine and confinement.

A motion was made by Councilmember McCain, seconded by Councilwoman Clay to approve a Resolution extending the City of Athens Disaster Declaration issued on March 19, 2020 due to the imminent threat to Public Health and Safety as a result of the spread of the Coronavirus (COVID – 19), Epidemic, as declared by the World Health Organization as a Pandemic on March 11, 2020. The motion carried unanimously.

CONSIDER FINAL READING OF AN ORDINANCE CONCERNING A REQUEST FROM TRITON ATHENS I, LLC FOR APPROVAL OF A SITE PLAN AMENDMENT FOR LOTS 1-5, BLOCK 1 OF THE TRITON ATHENS SUBDIVISION, R.A. CLARK SURVEY A-171, ALSO KNOWN AS 1006, 1010 AND 1012 EAST TYLER STREET

Ms. Borstad presented the item. She explained the top of the entire wall shall be at the minimum elevation of 516 feet. After discussion all openings are to be filled with permanent blocks. Temporary fencing may be used on top of the wall to maintain the 416 feet wall height for privacy. Discussion occurred.

Ms. Hambrick read the caption of the Ordinance aloud.

A motion was made by councilmember Gross, seconded by Councilmember McCain, to approve final reading of Ordinance for a site plan amendment for Lots 1-5, Block 1 of the Triton Athens Subdivision, R.A. Clark Survey A-171, also known as 1006, 1010 and 1012 East Tyler Street with the following stipulations: openings are to be filled with permanent blocks. Temporary fencing may be used on top of the wall to maintain the 416 feet wall height for privacy, however, when blocks are available the fence must be completed.

A motion was made by Mayor Montgomery, seconded by Councilmember McCain to approve the lease on 414 W. College Street with Spot On Safety, LLC. with the following stipulations: Required capital improvements to the structure, remove the difference of his lease payment and what the fair market value of the lease payment would be each year. The motion carried unanimously.

Mayor Pro-Tem Ed McCain conducted the meeting for item a) Prospect #1802

#### a) PROSPECT #1802

A motion was made by Councilmember Gross, seconded by Councilwoman Clay to approve Athens Economic Development Corporation to enter into an agreement with Prospect 1802 (Steritec Automation.) so long as the project does not impede Northward continuation of Commercial Street, also the property should be deeded upon successful issuance of a building permit and construction must commence 120 days after closing and should be complete within 18 months. The motion carried by the following vote: Ayes: Councilwoman Clay, Councilmembers McCain, Gross, and Smith Nays: None. Mayor Montgomery abstained.

Councilmember McCain suggested Public Communication be moved to the end of the agenda during the time frame of avoiding social gatherings in groups of more than 10 people.

Boux Napps, I have a question as to regarding why everything in Henderson county is running as normal? Not seeming to be taking precaution at all or preventative measures to make sure that we aren't hit hard with the virus, in ways such as shelter in place or even non essential jobs being MANDITORY shut down? Right now it is SUGGESTED that employees at non essential jobs stay home but employers of non essential jobs are still having employees work, until closed down by city or county. It could be perceived that until a handful of people get sick or someone dies from the virus in confirmed cases, that preventive measures will not be taken. Why wait until damage is done and then do damage control and not take preventive measures to not have any casualties? I understand trying to keep the economy afloat by letting businesses work as long as they can, but why is not making everyone stay home for 14 days and trying to kill the virus altogether not a better option than this lasting months and the virus infecting and spreading?

Mayor Montgomery requested a list of the comments and stated he would like to address the comments in the next City of Athens newsletter.

Mayor Montgomery stated there are no recorded COVID-19 cases in the City or in the workforce. He further stated there is one case documented in the East side of the County.

Mayor Montgomery stated after Governor Abbott's Executive Order on Tuesday, March 21, 2020 there was confusion regarding what cities should do. He stated going into the weekend, the City needed to clarify and update the past emergency declaration as there are questions from Citizens.

Elizabeth Borstad, City Manager, explained the City's original Order referenced GA-08 and GA-14 specifically supersedes GA-08. She stated the Resolution clarifies the City will follow GA-14.

Mayor Montgomery provided background information on the City issuing its first Declaration of Disaster. He further explained that the City Council is unable to do more or less than the Governor's Order.

Ms. Borstad explained that Legal Counsel has advised the city to follow the Governor's order, which is stated as a "Stay at Home Order."

Discussion occurred.

Mayor Montgomery stated other cities are looking at their playgrounds. He stated the virus can live on a hard metal surface for two (2) days. He stated families are still going to the parks with children playing on the playground. Mayor Montgomery stated he personally feels the playgrounds should be shut down, however, leave parks themselves open for walking and exercising and place signs not allowing children to play in the parks.

Councilmember McCain stated he is not in favor of shutting the parks down, he further stated it is not unreasonable to shut the playground equipment down. He further stated you risk injury and it places further stress on the medical professionals. Councilwoman Clay and Councilmember Smith agreed with the comments.

Mayor Montgomery read portions of the City's Declaration:

**THEREFORE**, Be it Declared by the Mayor of Athens, Texas that the Disaster Declaration issued by the City Council of the City of Athens on March 23, 2020 shall be amended as follows;

- 1. A local state of disaster is hereby declared for Athens, Texas pursuant to §418.108(a) of the Texas Government Code.
- 2. This amended declaration of a local state of disaster shall be given prompt and general publicity and shall be filed promptly with the County Clerk, pursuant to §418.108(c) of the Government Code.
- 3. This declaration of a local state of disaster activates the City of Athens Emergency Plan.
- 4. The City of Athens Declaration Plan incorporates the Governor's Executive Order GA-14 and <u>all amendments or additional orders related thereto</u> and not superseded by GA-14.
- 5. All individuals currently living within the City of Athens are directed to shelter at their place of residence. For the purposes of this Order, residences include hotels, motels, shared rentals, and similar facilities. To the extent individuals are using shared or outdoor spaces, they must, at all times, as reasonably as possible maintain social distancing as specified by Center for Disease Control (CDC).
- 6. This order does not prohibit individuals from accessing essential services or from engaging in essential daily activities as outlined by Executive Order GA-14 issued by Governor Greg Abbott on March 31, 2020.
- 7. The City of Athens will close all City Parks to group activities and the use of playground equipment will not be allowed. Walking paths and outdoor space will remain open with social distancing requirements as outlined by the CDC.

Pursuant to Tex. Gov. Code §418.173, failure to comply with an emergency plan or with a rule, order, or ordinance adopted under the plan, including any executive order, proclamation, or regulation issued by the Governor during a state disaster or by the Mayor or City Council during a local disaster, is an offense

- 8. punishable by a fine not to exceed \$1,000, confinement in jail for a term not to exceed 180 days, or both fine and confinement.
- 9. This Declaration shall take effect immediately from and after its issuance and shall remain in effect until the City Council of the City of Athens takes additional action.

Additional discussion occurred.

Councilmember McCain stated that the City is not doing "more" or "less than" what is in Governor Greg Abbott's Order. He further stated the City is not taking steps beyond what the Governor has ordered.

Mayor Montgomery stated the City can only do what is in the Executive Order.

Mayor Montgomery stated citizens want us to go into the essential businesses and try to shut them down or scatter their employees. He stated we cannot do that. He stated we can only do what is in the Order from Governor Abbott.

Councilwoman Clay further stated unless you work at an Essential Business, are getting groceries, gas or exercising you "Stay Home".

There was discussion regarding the enforcement of the fines as outlined in the amended order.

Councilmember McCain expressed concern with the effect COVID-19 will have on local business owners and the economy. He further stated non-essential business owners should be able to go to their business establishment and work as long as they do not violate the rule, limiting the number of people at the location and practice social distancing.

Councilmember McCain stated for the record he wanted it documented that a fine will not be issued to non-essential business owners who are checking on their business.

Discussion occurred.

Councilwoman Clay read the following sentence from Governor Abbott's video recording statement released on April 1, 2020.

This is Governor Abbott with COVID-19 spreading across Texas I issued this Executive Order that requires all Texans to stay at home except to provide essential services or do essential things, like go to the grocery store. Councilwoman Clay further stated this is what the City is cosigning.

Councilmember Smith stated, "the key lies with the Citizens and we need the Citizens to self-govern". He stated self-governing and compliance is the key to getting over this as soon as possible.

Councilmember McCain stated, "it is more important than ever to do your business locally and keep the economy moving as much as we can during this time".

Mayor Montgomery stated this is the City's "Shelter in Place". The City is unable to do any more or any less.

A motion was made by Councilmember Smith, seconded by Councilwoman Clay to approve a Resolution amending the City of Athens Disaster Declaration issued on March 23, 2020 due to the imminent threat to Public Health and Safety as a result of the spread of the Coronavirus (COVID – 19), Epidemic, as declared by the World Health Organization as a Pandemic on March 11, 2020. The motion carried unanimously.

Enclosed please find the Henderson County 9-1-1 Communication District's budget for the fiscal year 5/2020-4/2021. The Health and Safety Code 772.309 states the 9-1-1 District shall submit their annual budget to participating jurisdictions for your review and approval. The Henderson County 9-1-1 Communication District Board of Managers analyzed and approved the FY 2020/2021 budget during our March 10th meeting.

The Henderson County 9-1-1 system became operational March 13, 1991, serving the citizens throughout Henderson County. The District provides equipment to connect emergency calls from all points in the county to one of three Public Safety Answering Points (PSAP). Calls are automatically routed to either the Athens Police Department PSAP, the Gun Barrel City Police Department PSAP or the Henderson County Sheriff's Office PSAP, depending upon the callers' physical location. The District continues to enhance and update our state of the art 9-1-1 and GIS mapping systems.

During the 2019-2020 fiscal year we completed upgrades to the 9-1-1 Call Handling system, 9-1-1 network, and District office systems. These upgrades enhanced our Text to 9-1-1 capabilities, abandoned call handling processes, and wireless caller location capabilities. The District launched SMS text to 9-1-1 during FY 2016 – 2017, and this year's upgrade greatly enhanced this service. The District will ultimately be able to transmit pictures, video or other digital files which can help emergency responders in their effort to provide aid. NG 911 will also enhance 9-1-1 call routing and interoperability with other agencies. The District continues to invest capital to upgrade hardware, software, and networks to provide state-of-the-art emergency communication within our jurisdiction.

#### ORDINANCE 2020-O-

AN ORDINANCE AMENDING THE ZONING MAP DESCRIBED IN CHAPTER I, SECTION 3 OF THE ZONING ORDINANCE OF CITY OF ATHENS, TEXAS, BY APPROVING A ZONING CHANGE FROM AGRICULTURE TO SINGLE-FAMILY – 5 AND A SPECIFIC USE PERMIT FOR A MANUFACTURED HOME, PROVIDING A REPEALER CLAUSE, A SEVERABILITY CLAUSE, AND AN EFFECTIVE DATE.

WHEREAS, on the 6<sup>th</sup> day of April 2020, the Planning and Zoning Commission of the City of Athens, Texas after due notice and hearing did hereby vote to recommend approval of the zoning change from Agriculture (A) to Single-Family – 5 (SF-5) and a Specific Use Permit for a manufactured home for the below described property owned by Rodney Session:

Lot 5 F. M. Coker Tract B. C. Walters Survey, Abstract 797 also known as 907 Cream Level Road

**WHEREAS**, on the 13<sup>th</sup> day of April 2020, the City Council of the City of Athens, Texas after due notice as required by law, held a public hearing for said site plan and heard from those opposed to said modification and those in favor of same. After the close of the public hearing, the ordinance amendment was read aloud for the first time as required by Article III, Section 3.11 of the City of Athens Charter.

## NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ATHENS, TEXAS

Section 1. The Zoning Map described in Chapter I, Section 3 of the City of Athens Zoning Ordinance is hereby amended to grant the zoning change from Agriculture (A) to Single-Family – 5 (SF-5) and the Specific Use Permit for a manufactured home for the above described property.

Section 2. Should any clause, phrase, sentence section of this Ordinance be deemed invalid or unconstitutional by a court of competent jurisdiction, said finding shall not affect the remaining clauses, phrases, sentences or sections of this Ordinance.

Section 3. Any ordinance, resolution or order previously passed and/or adopted by the City Council, or any part thereof, if found to be in conflict with the provisions of this Ordinance, shall be resolved in favor of the terms and conditions of this Ordinance, and any prior conflicting ordinance, resolution or order or any part thereof, is hereby repealed to the extent of said conflict.

Section 4. This ordinance shall be and become effective from and after its adoption and publication in accordance with the provisions of the Charter of the City of Athens, Texas.
