1. Kiwanis Park Project - \$54,000 invested in the park by Kiwanians for installation of a new fence on the South side; with the City Council considering a 50% match

3. O.D. Baggett Park – contract with engineering and architectural firm has been executed

4. Provided a brief update on improvements that will be made at the O. D. Baggett Park.
5. Informed the Board Members that he would bring the site plan for O. D. Baggett Park to the next Parks Advisory Board Meeting
6. Informed the Board Members that Staff is considering resistant materials for vandalism at O. D Baggett
