PUBLIC HEARING CONCERNING A REPLAT OF LOTS A, 1-4, BLOCK 25, PARK HIGHLAND ADDITION AND PART OF THE RESIDUE OF A CALLED 81 ACRE TRACT IN VOLUME 109, PAGE 140 CREATING LOTS 1-6, BLOCK 1, BRYSON PLACE ADDITION.

Barbara Holly AICP, Managing Director of Development Service, stated that this is located at the northeast intersection of Lindsay and Bryson. The applicant proposed to create six duplex lots on the property. Ms. Holly explains that Mr. Tidmore downzoned in 2016 from Multifamily 4 to Multifamily 2 to provide for the duplex development. Ms. Holly states that the plat reflects public easements for water, sewer and gas. She recommends approval for the plat as it has met all requirements.

Mr. Tidmore explained he wanted the Planning Commission to be aware that the plat has a residual piece from an 81 acre piece recorded in volume 109, page 140 deed records of Henderson County, Texas. He stated that the small piece of property will be the backyard to Lot 1 of the duplex. A motion was made by Member Ingram and seconded by Member Autry to close the public hearing. The motion carried unanimously.

After discussion, a motion was made by Member Ingram and Seconded by Member Autry to accept the replat of Lots A, 1-4, Block 25, Park Highland Addition and part of the residue of a called 81 acre tract in volume 109, page 140 creating Lots 1-6, Block 1 Bryson Place Addition..
