Chair Bateman opened the Public Hearing.

Barbara Holly, Director of Development Services, explained to the Board that Mr. Tidmore is requesting a variance which will reduce the number of parking spaces from twenty-four (24) to twenty-two (22) spaces at Bryson Park Subdivision. Ms. Holly stated that in designing the subdivision, the buildings and parking spaces have been placed to limit impact to the trees and tree roots. Ms. Holly stated the required number of spaces is twenty-four (24), but twenty-two (22) is sufficient.
