The City Council of Seven Points, Texas will meet for a Regular Meeting, Thursday, June 11, 2020 at 7:00 p.m. in the Council Chambers of City Hall to discuss the items listed below.

1. Call to order and Roll Call; Mayor Gerald Taylor, Mayor Pro Tem Skippy Waters, Council Members Cheryl Jones, Andy Perdue, Kenneth McConnell, and Charles White. (Quorum present/not present)
2. Invocation and Pledge of Allegiance to the Flag.
3. Public Comments.
Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the public comments section of the meeting or at the time the agenda item is called for discussion by the Mayor. Speakers shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of city employees or staff is prohibited. Those wishing to address the Council regarding an item not on the agenda must be a citizen, property owner or business owner of Seven Points. Comments on such non-agenda items shall be limited to three (3) minutes. The Council will not comment on items not on the agenda; however, the Council may refer the item to city staff for research, resolution, or referral of the matter to the Council as a future agenda item.
4. Consent Items.
 - A. Approve Minutes from the May 14, 2020 Regular Meeting and the May 18, 2020 Budget Workshop.
 - B. Approve May Financials; Subject to Audit.
5. Discuss and vote on the Fire Departments ability to use the Rec Center fields for their annual fireworks show.
6. Discuss and vote on approving James Craig to be hired as the City Prosecutor.
7. Discuss and vote on approving Lindsey Anderson to the Economic Development Corporation.
8. Mayor Taylor to give update on the status of Quick Books and getting quotes for the Annual Audit. Take any necessary action.
9. Discuss and vote on putting a proposition on the November ballot to re-allocate one half (1/2) of the one fourth (1/4) percent of the sales tax collected by the Seven Points Economic Development Corporation, to be placed in a special street maintenance and repair account.
10. Discuss and vote on the ability of Audrey Lacey to place an RV on her property at 321 Pine Street to live in while her home is being remodeled for 6 months to a year.
11. Discuss and vote on the hiring of Charlotte Scrimshire as a part time Court Clerk.
12. Discuss and take any necessary action on City equipment being used and taken to Council Members or Mayor's houses.
