The City Council of Seven Points, Texas will meet for a Special Called Meeting, Tuesday, August 4, 2020 at 1:00 p.m. in the Council Chambers of City Hall to discuss the items listed below.

1. Call to order and Roll Call; Mayor Gerald Taylor, Mayor Pro Tem Skippy Waters, Council Members Cheryl Jones, Andy Perdue, Kenneth McConnell, and Charles White. (Quorum present/not present)
2. Invocation and Pledge of Allegiance to the Flag.
3. Public Comments.
Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the public comments section of the meeting or at the time the agenda item is called for discussion by the Mayor. Speakers shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of city employees or staff is prohibited. Those wishing to address the Council regarding an item not on the agenda must be a citizen, property owner or business owner of Seven Points. Comments on such non-agenda items shall be limited to three (3) minutes. The Council will not comment on items not on the agenda; however, the Council may refer the item to city staff for research, resolution, or referral of the matter to the Council as a future agenda item.
4. Consent Items.

The July 9, 2020 Regular Meeting was Canceled.
 - B. Approve June Financials; Subject to Audit.
5. Discuss and take any action necessary on the renewal contract for the telephone system.
6. Discuss and take any action necessary on a Proposition for the November ballot to designate a percentage of the EDC's sales tax money to go towards road maintenance.
7. Discuss and vote on contracting with Henderson County to hold our November 3, 2020 Election simultaneously with them.

Council will adjourn to Executive Session to discuss items 8, 9 and 10.
8. Take any necessary action on the discussion in Executive Session about the incident that took place on July 17, 2020 that involved Officer Cameron Beckham.
9. Discuss and vote on the hiring of Dylan Bice for Maintenance.
10. Discuss and vote on the hiring of William Dickens for Maintenance.
11. Adjourn.
