Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the public comments section of the meeting or at the time the agenda item is called for discussion by the Mayor. Speakers shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of city employees or staff is prohibited. Those wishing to address the Council regarding an item not on the agenda must be a citizen, property owner or business owner of Seven Points. Comments on such non-agenda items shall be limited to three (3) minutes. The Council will not comment on items not on the agenda; however, the Council may refer the item to city staff for research, resolution, or referral of the matter to the Council as a future agenda item.

7. Discuss and take any action necessary on the recommendation of Planning and Zoning on the project of The Casita's at Seven Points. (Mac McKinsey)
8. Schedule a definite date that volunteers and Shirley can get together on how to use the current accounting software more efficiently for budgeting. (LaJohnna Wells)
9. Vote on Resolution 176; Bank Signatures.
