The City Council of Seven Points, Texas will meet for a Regular Meeting, Thursday, January 12, 2023 at 7:00 p.m. in the Council Chambers of City Hall to discuss the items listed below.

- 1. Call to order and Roll Call; Mayor Skippy Waters, Mayor Pro Tem LaJohnna Wells, Council Members Andy Perdue, Charles Longacre, and Kelly Logsdon. (Quorum present/not present)
- 2. Invocation and Pledge of Allegiance to the Flag.
- Public Comments.

Pursuant to Texas Government Code section 551.007, members of the public may speak on an agenda item during the public comments section of the meeting or at the time the agenda item is called for discussion by the Mayor. Speakers shall be given three (3) minutes to speak. A speaker needing a translator and/or interpreter may be given six (6) minutes to speak. Criticism of city employees or staff is prohibited. Those wishing to address the Council regarding an item not on the agenda must be a citizen, property owner or business owner of Seven Points. Comments on such nonagenda items shall be limited to three (3) minutes. The Council will not comment on items not on the agenda; however, the Council may refer the item to city staff for research, resolution, or referral of the matter to the Council as a future agenda item.

- 9. Discuss and take action on rezoning and site plan approvals
 - A. Pursuant to the notice properly mailed out on December 1, 2022, a public hearing shall be conducted concerning the rezoning and site plan approvals of that certain 29.32 acres of land located south of Kelly Lane and East of Highway 274 described as "AB 503 D MUCKLEROY SUR, TR 7A (RE:TR 7B)" of the City of Seven Points, Henderson County, Texas. Previously on September 8, 2022, the City Council of Seven Points unanimously approved the rezoning of this property. Mayor Waters and City Secretary executed Ordinance No. 365 on this same date, thereby officially changing the zoning of the property. Then a few weeks later it was discovered that public hearing notices about the proposed rezoning had not been properly mailed to nearby property owners. So, this is a do-over. As such, the applicant's agent, Hal Watson, shall first make a presentation to explain the rezoning and site plan approval requests, Then the public hearing shall commence.
 - B. Upon Completion of the public hearing, the City Council may vote to re-affirm/re-approve Ordinance No. 365, thereby rezoning the property again
 - C. Finally, the City Council may vote to approve applicant's site plan.
