LEADERSHIP LETTER BY STEVE MARTIN, PRESIDENT & CEO



“Time flies when you’re having fun.” It is hard to believe that we are already into September, but a year after COVID shut everybody down, at West Texas Rehabilitation Center, we are definitely having more fun than we did in 2020.

In May, we honored 26 wonderful folks we lost in 2020. In two separate ceremonies, we heard inspirational story after story of folks who had dedicated their lives to helping others, including West Texas Rehab. I cannot imagine where we would be today had it not been for caring folks who have been so kind over these past 68 years as well as those who continue to support our mission each and every day.

Folks like Donnie Schwertner with Top-Tier Grain & Feed in Miles, Texas. Donnie basically grew up helping West Texas Rehab as his mom, Dolores, directed the Retired & Senior Volunteer Program (RSVP) for 34 years. He and his wife Danelle and their family continue to find ways to stay involved

with and support West Texas Rehab, our mission, and our patients.

Beginning in the fall of each year our Round-Up for Rehab events always begin to heat up. I hope you will check out ways you can be involved by volunteering your time, donating animals to our sales, making cash donations, or through the purchase of raffle tickets, gun board squares, or of items being sold at our many events. The Round-Up for Rehab, at 62 years old, is our longest running fundraiser and speaks to the neighbor-helping-neighbor spirit at the heart of West Texas Rehab and the agricultural community. The success of the Round-Up has depended on volunteers like Homer Grimes “who would do anything for anybody,” especially children, as he knew the value of owning and raising livestock and the importance of helping others. And patients like Gunner Quirk, who now can attend therapy at West Texas Rehab in San Angelo instead of enduring the 4-hour drive one-way to Fort Worth.

“Time flies” is an understatement. As we get older for sure! I also realized the other day, I have over 30 years experience in rehabilitative care. In my years working in for-profit, hospital-based not-for-profit, and freestanding not-for-profit, I have seen therapy, audiology, orthotics, prosthetics, and hospice delivered to a multitude of patients, and I will put our staff, our facilities, and our equipment up against anyone in the Big Country, Concho Valley, or the country.

There have been many changes in our local

healthcare environment in the past year with our local hospitals having more control than ever before. At West Texas Rehab, we are trying to partner with the hospitals in “win-win” relationships where we can. Beneficial cooperation has been achieved in San Angelo for hospice, in Abilene and San Angelo for orthotics-prosthetics and in Abilene for the orthopedic residency program.

One thing I would ask you all, as supporters of West Texas Rehab, to do for us. Regardless of who your employer is, who your doctor is, who your insurance is with, or what your diagnosis is, remember that it is 100% your choice where you receive rehab and hospice services. Please be a vocal proponent and advocate with family and friends for receiving services at West Texas Rehab, Hospice of the Big Country, and Hospice of San Angelo.

We need you to advocate for the best care available to you and your family, and we’re confident that care is provided by West Texas Rehab.

Don't wait! Give us a call and let's get this ball rolling! ★

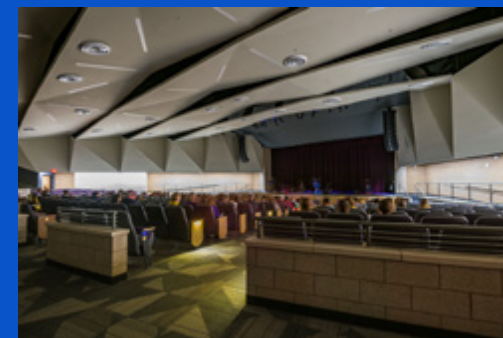

Gunner Quirk

This story of a young, aspiring cowboy is one that is sure to provide hope and inspiration to us all. Let us introduce you to 5-year old Gunner Quirk.

“I just wondered if he was ever going to walk and was living in fear of not knowing what would happen next”, said Katrina Quirk, Gunner’s mom. At just 9 months old, Gunner was diagnosed with Kabuki Syndrome, a rare genetic disorder that affects 1 in 32,000 births worldwide. This syndrome portrays a variety of symptoms including: intellectual impairment, growth delays, low muscle tone, feeding difficulties, vision and hearing impairments, and it’s common to be on the autism spectrum. After 4 rounds of in-depth genetic testing, the Quirk family finally felt like they had some answers on Gunner’s condition. However, their journey was just beginning. Due to the specialization and rarity of Gunner’s condition, the Quirk family traveled 3x per week to Cook Children’s Hospital in Fort

Worth to visit with 18 different types of specialists for the past 4 years.

The Quirk family settled into life in West Texas in May 2020, when Jeff Quirk signed with Cargile Cattle Company and became Foreman of Cinco Cattle Company, which is located in Sterling City and co-owned and operated by Sarena Terry, a West Texas Rehabilitation Center Board Member. The Quirk family established pediatric care at Shannon Medical Center and after research and recommendation from Sarena, they requested to be referred to West Texas Rehab for Gunner’s therapy. Instead of the 4-hour drive one way to Fort Worth, the Quirk family now only has a 35-minute drive to get Gunner the help he needs. Currently, Gunner participates in physical therapy, occupational therapy, speech therapy, and audiology. Receiving treatment from West Texas Rehab has allowed this ranching family to have the best of both worlds - life on a ranch and a “one stop” location for Gunner’s

rehabilitative care. The treatment he receives has not only given the Quirk family a familiar place to call home for his care but has also alleviated financial burdens.

Katrina says, “The therapists he sees love him like their own and encourage the best possible version of him. Gunner is a fighter and has been a driven child from the moment he was born. Early on, he was going to be fitted for a wheelchair, but that same day, he got a therapy horse named Scooter. Since then, no wheelchair has been needed. He continues to make great strides, and he roped his first goat just the other day!

Gunner’s favorite thing to wear is his hat and boots and he can turn just about anything into a rope.” While Gunner is fairly new to our facility, he has quickly become attached to his therapists and claps his hands in pure delight when it’s time for his treatment. ★

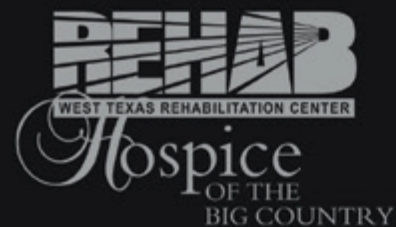

Ashley Rich, ACSM-EP/ASCM-CPT

The early symptoms of Parkinson’s Disease may be mild and go unnoticed. But people experiencing tremors, slowed movement, rigid muscles, stooped posture, or problems with gait, balance, speech, and handwriting should see a doctor to diagnose their condition and to rule out other causes for these symptoms. Parkinson’s cannot be cured, but physicians may prescribe medication and recommend speech/language therapy, physical therapy that focuses on balance and stretching, and maintenance through exercise therapy.

West Texas Rehabilitation Center provides many services for physical rehabilitation of Parkinson’s patients.

Physical therapists have been trained in rehabilitation of those diagnosed with Parkinson’s. West Texas Rehab also has exercise therapy, under the coordination of Ashley Rich, who is degreed in Exercise Science and certified by the American College of Sports Medicine as an Exercise Physiologist and a Certified Personal Trainer.

“Exercise helps strengthen the body, it helps with coordination to slow tremors, and it helps the brain release dopamine,” Ashley explains. “Basically, it helps patients manage life longer.”

Ashley, who has worked at WTRC since 2015, is the coordinator of

Pacesetters, an exercise therapy program designed to address the specific challenges Parkinson’s clients face. Most of the clients who come to Ashley have transitioned out of physical therapy and need maintenance, but sometimes doctors will send a patient to Ashley if they feel the patient is clear to start exercise and does not need physical therapy.

Pacesetters participants choose from three options for exercise therapy:

1. One-on-one personal training with Ashley, for clients who have usually finished rehab and are not comfortable going to a gym;

2. Parkinson’s Power Hour, a twice-weekly exercise class of 10-12 clients, led by Ashley, with assistance from physical therapy students from Angelo State University; and

3. An independent gym membership, entitling members to use the pool and gym during the day Monday through Friday, with Ashley or trained personnel present.

Ashley designed Pacesetters to appeal to the individual needs and preferences of the clients it serves. Some participants have been with Ashley since the beginning of her time with West Texas Rehab; others have taken breaks and come back.

“I enjoy working with people who may have thought in the beginning that there was no way they could exercise again,” she says. “I love teaching them that it is still possible to exercise at any age or with any condition they may have. Seeing their progress and accomplishments is what makes me feel rewarded. Seeing them live a more functional and independent life and how happy that makes them is why I love my job.”

Participants in Pacesetters pay reasonable rates on a pay-as-you-go basis; they do not sign contracts. For more information about Pacesetters, please call Ashley at 325-223-6479.

Some patients may also need speech/language therapy as part of the Parkinson’s treatment options. The Summer 2019 issue of Round-Up, West Texas Rehab’s quarterly publication, included an article on Khristina Douglas, Speech-Language Pathologist at West Texas Rehab, and SPEAK OUT! – individual therapy sessions for Parkinson’s clients and The Loud

Crowd maintenance group. Ashley and Khristina frequently collaborate when working with Parkinson’s clients.

West Texas Rehab is proud to be a facility that offers many services to meet the needs of Parkinson’s patients: physical therapy, speech/language therapy, and exercise therapy with options to fit the preferences of all participants.

West Texas Rehab could not do what we do without the kind, generous support of our donors, people like you who want to know they are doing what they can to help friends and neighbors -- as Ashley says – “manage life longer.” That kind of kindness is priceless, and we thank you for it. ★

in April of 2020 with thirty-four years of dedicated service. Donnie remembers “growing up” at the Rehab Center and spent many hours volunteering and helping his mom.

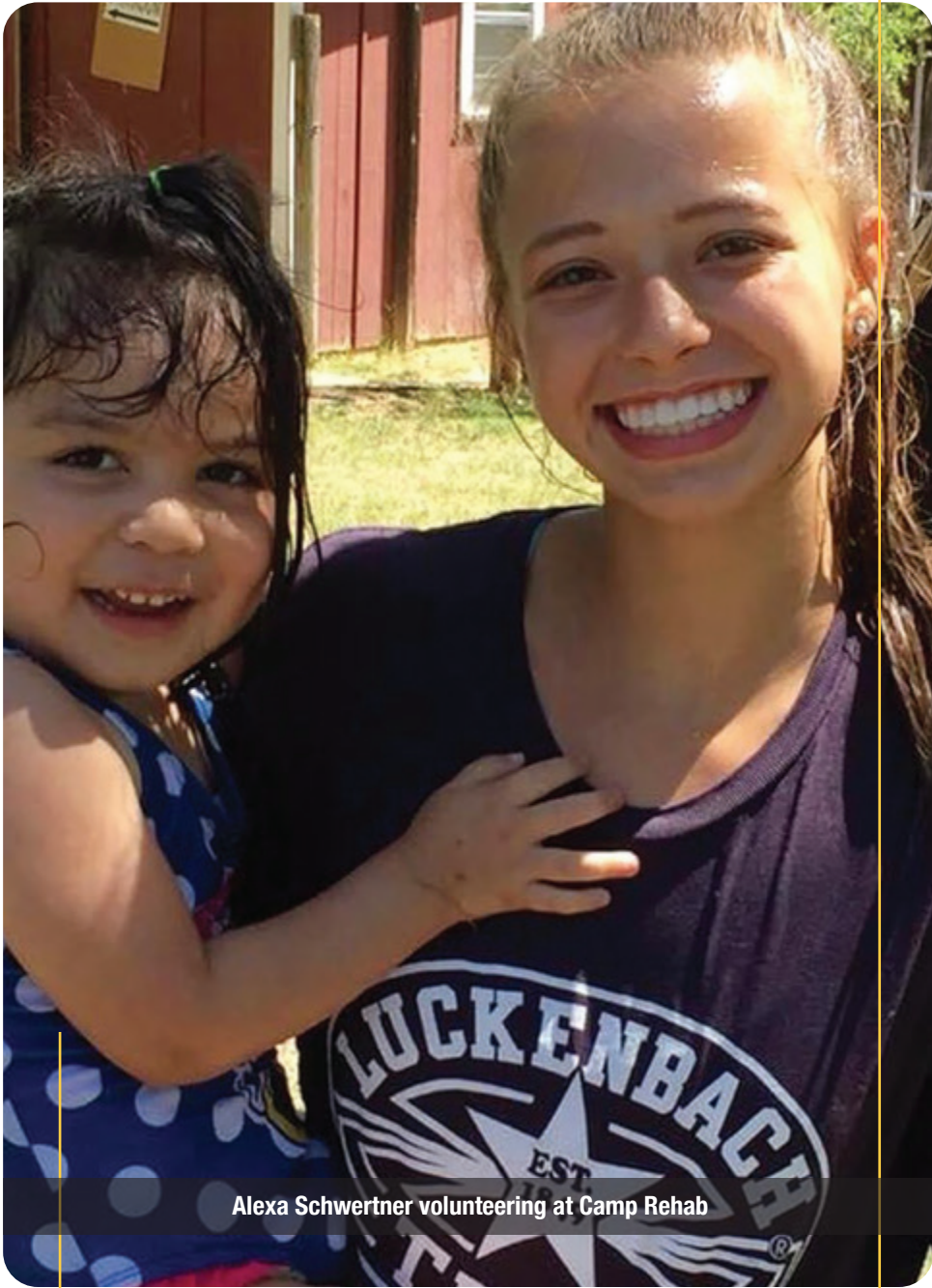
Donnie and his wife Danelle now own and operate Top-Tier Grain and Feed in Miles, Texas. Donnie approached us a

has known Donnie for several years, so it was a perfect fit to kick off WTRC’s Grain Round-Up this year.

Not only do Donnie and Danelle generously give their time, but they have also taught their three daughters the importance of volunteering their time and efforts as well. Their oldest daughter, Alexa, has been a volunteer at Rehab Camp for three years now. Her first year as a camp buddy she was partnered with a child camper named Addy. Addy was nonverbal at first, but after that week, Alexa was the first person Addy spoke to! Four years later, Alexa is going to babysit Addy and her sister after school as her part-time job while she attends Angelo State University this fall. “The West Texas Rehab Center has a way of making you fall in love with the people and you just want to be part of the magic that happens here. I’ve learned that the more blessed we are in our lives; we can then pay it forward to others.” says Danelle, Alexa’s mother.

To date, the Grain Round-Up has brought in over \$5,000 for the West Texas Rehab Center with plenty of room to grow in the years to come. Donnie states, “It’s in our blood to volunteer and help at WTRC. If you guys need anything, our family will always be here for you. We may need the services Rehab offers one day, but the Rehab can’t operate without funding and it’s important for us to give back when we can.” ★

Those businesses became fixtures in Sweetwater for years, allowing Homer the ability to do what he loved most: volunteer to help others!

Homer’s volunteering took many forms (you don’t get awarded Sweetwater’s Outstanding Male Citizen of 2015 for nothing!), but for us at West Texas Rehab it began when Don

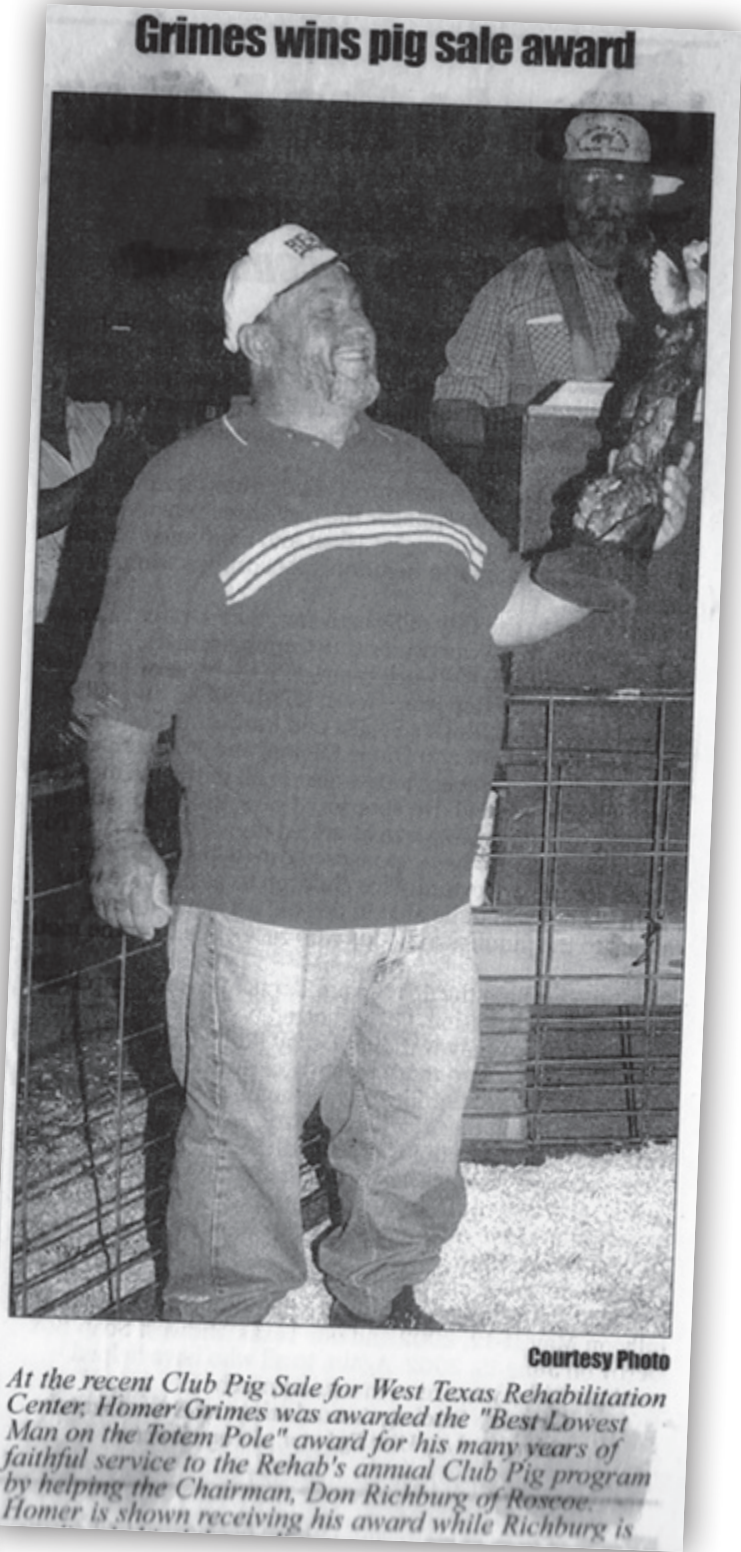

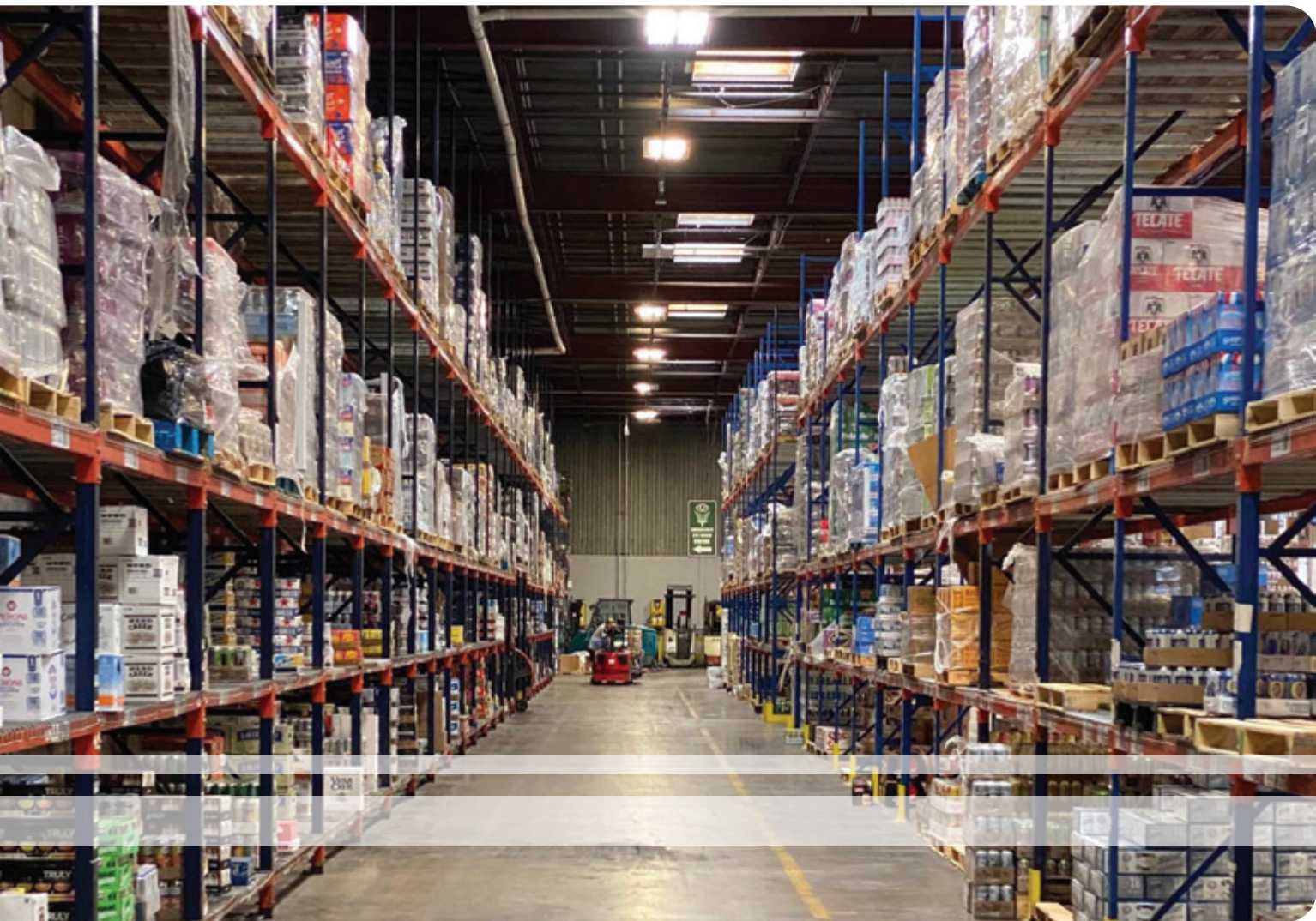

West Texas Rehabilitation Center is pleased to shine a spotlight on one of the businesses using our WorkSTEPS Program, consisting of a physical fitness and musculoskeletal exam and completion of job specific tasks to confirm that a candidate is physically fit enough to perform the job for which they have been hired.

Glazer’s Beer and Beverage, located at 2030 W. 306 Loop, has been a wholesale distributor of alcoholic and non-alcoholic beverages in San Angelo since 2005. It is part of Glazer’s Beer and Beverage, LLC, headquartered in Dallas, with offices

servicing Texas, Louisiana, and Arkansas.

GBB has consistently reported strong sales in San Angelo and offers benefits and a 401K to its 64 employees. During the pandemic, when many businesses were downsizing, GBB was able to offer bonuses and retain and even add workers to its already stable workforce. Justin Gomez, branch office manager at Glazer’s Beer and Beverage in San Angelo, has been with the company for 16 years. He reports that most managers have worked there for 10-15 years.
